RULES & REGULATIONS

- **NO FIVESOMES. PLAY READY GOLF. • Play USGA rules.**
- Local rule: distance measuring device (rule 14-3).
- Water hazard (yellow stakes): drop a ball behind the water hazard, keeping the point at which the original ball last crossed the margin of the water hazard directly between the hole and the spot on which the ball is dropped. One stroke penalty.
- Lateral water hazard (red stakes): drop a ball outside the water hazard within two club-lengths of, and not nearer the hole than, the point where the original ball last crossed the margin of the water hazard. One stroke penalty.
- Per WA Liquor and Cannabis Board Laws (WA 314-16-110), all beverages must be purchased from the golf course. We provide adequate refreshments at fair and reasonable prices.
- Repair all divots and ball marks, rake all bunkers.
- Power golf carts must stay on designated cart paths and observe all cart signs that are located on the course.
- Golfers under the age of 12 must be accompanied by an adult unless the Golf Professional on duty has determined that the junior golfer is adequately equipped to play by demonstrating his knowledge and ability to play golf.
- Each player must have his/her own set of clubs.
- The course marshal is on the course to help you enjoy your game and enforce course rules and regulations. His/her responsibilities include checking golfers for green fee and trail fee receipts, checking coolers for alcohol not purchased from the course, helping resolve conflicts on the course, helping in cases of emergency, protecting the course from misconduct by any golfer, and ensuring the PACE OF PLAY is appropriate. Please give the marshal your fullest cooperation.
