Washington State Veterinarian's Regulations

All Out-of-State horses are required to have an ownership inspection (brand) from the state of origin prior to entering the fair. All Out-of-State horses are required to obtain a certificate of veterinary inspection except for Idaho and Oregon horses traveling into Washington with their owners in personal vehicles for roundtrip visits of not more than 96 hours provided the fair management provides veterinary inspection on arrival and rejects any unhealthy animals. This exemption does not apply during emergency disease conditions declared by the State Veterinarian or extend to any required testing. All out-of-state horses over 6 months of age are required to have evidence of a negative test for EIA (equine infectious anemia) within 12 months of entry. Horses from Oregon are exempt from the EIA test. Any horses coming from Texas must call 360-902-1878 for special instructions for entry requirements.

No animal from a quarantined area or premises may be permitted to enter the Fair. The Out-of-State exhibitor's permit number for the 2011 Fair is 91-WA5717. Your veterinarian need not call the Washington State Department of Agriculture if they use this permit number on health certificates. A new number will be issued each year. The Fair Veterinarian **MUST AND WILL** reject any animal with infectious or a contagious diseases or ectoparasites including, but not limited to, ringworm, warts, pinkeye, strangles, contagious ecthyma, scabies, lice, mites, ticks and fleas. Animals exhibiting disease symptoms during the course of the Fair will be rejected by the Fair veterinarian and removed from the exhibit area. The Fair veterinarian's professional decision as to the health status of an animal will be final and be upheld by Fair Management. Exhibitors needing veterinary services will call their own veterinarian at their own expense.

HORSE DEPARTMENT INFORMATION

COMPLETING ENTRY FORMS: Entries will be limited to a first-come / first-served basis should the Fair run out of room to house the animals. All exhibitors must use entry form found at the conclusion of the book and they must be postmarked on or before August 9, to Fair Entries, 404 N Havana Street Ste 1, Spokane Valley WA 99202-4663. Particular care should be given in the preparation of all entry forms. Full and correct information must be given. Please list affiliated club / group (or any other individual) you would like to stall near on the entry form. If you do not list club/group you will be stalled as an individual. Moving and/or changing stalls will only be permitted with Superintendent approval. Moving and/or changing stalls without prior approval may result in the loss of premiums. Staff will be available in Bay 2 from 4:00 to 7:00 p.m. on August 9 to assist you with your entry form if needed. If housing remains, late entries will be accepted with entry fees doubled. No refund of entry or camping fees will be made. All registered breeds not specifically listed are encouraged to enter either Class 10. Should ten or more animals of the same breed be entered in either Class 2, 7, or 10 – they will be split out from this class and judged as a separate class. A copy of the registration papers must be

attached to entry form. Horses that do not have registration papers must be shown as Grade. Exhibitors showing two or more horses are required to pay entry fees on each horse (except mare and foal class which counts as one). All exhibitors must show at least one horse in halter or showmanship to be eligible to compete in riding classes including the O-Mok-See. A horse can only be shown by one exhibitor and only in one department.

ARRIVING AT THE FAIR: Please take animals to the livestock gate on Broadway Avenue for check-in. The Horse Superintendent and/or Fair Veterinarian will make the initial inspections for entry into the Fair. The Fair Veterinarian's professional decision as to the health status of an animal will be final and will be upheld by the SCF&EC Advisory Board and Fair Management. Only animals competing at the Fair will be allowed to be stalled on the grounds. Animal exhibits will not be allowed on the grounds until the arrival time as listed prior. Please contact the Superintendent if you are unable to arrive during designated times. Horses arriving, with prior Superintendent approval, outside of check-in hours as stated in their respective departments will need to adhere to current Fair and Expo Center policy including, but not limited to, quarantine, until inspected by the Fair Veterinarian and/or Superintendent. Horses will be unloaded and put into assigned stall and can only be removed for stall cleaning, scheduled showing, and exercising. The wash rack should be used for spot cleaning only. Animals may be taken to designated areas only. The Superintendent shall assign stalls to exhibitors and such decisions will be final. Stall cards must be displayed at each area in order to receive prize money. The Fair will furnish bedding. Fresh bedding / shavings will be available in bins or areas near the buildings where exhibits are located. Bedding / shavings will NOT be delivered to each exhibitor's stalling area. Stall cleaning, new bedding, and the cleaning of aisles must be completed prior to 8:00 a.m. Grain shall be furnished by the exhibitor. Hay will be for sale on the grounds. Fans in the barns are prohibited. All horses shall be properly trimmed or shod, groomed, etc., before coming to the Fair. Horseshoeing and trimming are not permitted on the grounds except in the case of an emergency and with prior approval from the Superintendent. A mandatory exhibitors meeting will be held for all exhibitors at 9:00 p.m. on the day of their arrival. Rules regarding exercise and show times will be explained at the mandatory meeting.

PASSES (OPEN): Exhibitors with one to three exhibits will be issued one livestock exhibitor pass allowing them six entrances to the Fair to care for their animals. Additional passes will be allotted for each additional three animal entries with a maximum of five per family / group. A person must have an exhibit on the grounds prior to receiving gate admission passes as well as a validated vehicle parking pass from the Livestock Office (one parking pass per exhibitor). Open exhibitors may not purchase Attendant Passes.

SHOWING AT THE FAIR: **This year's judge will be TBA.** Show schedules will be posted conspicuously and they will run in the order listed. Deviations from the order may occur due to facility accommodation, however all changes will be communicated in advance (appeal to the judge may be available due to cause). When class is called, it is exhibitor's responsibility to be ready to show. An animal that is not physically fit shall NOT be shown or displayed. At the discretion of the General Livestock Superintendent or Department Superintendent, an exhibit can be excluded from showing if that animal is not fitted or properly prepared for the Fair. Exhibitors entered into the Interstate Fair are required to maintain a level of conduct compatible with the Show Ring Ethics. Violation of Show Ring Ethics and/or violation of Department Rules shall, at the discretion of the Superintendent, forfeit exhibitor's prize money and/or forfeit continued eligibility in Fair competition. Persons found in violation shall be required to immediately leave the barn with their animal(s) and return any / all Fair passes, day tickets, or other competition issued coupons / tickets. The Fair will not be responsible for injury to persons or any property damaged as a result of showing livestock. Exhibitors using unusual / visible animal restraint devices must obtain approval of the Livestock Superintendent. Exhibitor must post a written explanation for the restraint device. Each animal shall be placed according to the decision of the judge and such placing shall be final. Anyone interfering with a judge will forfeit the right of prize money awards. Any protest regarding the judging shall be made in writing and must be accompanied by a \$25.00 deposit. Such protest must state plainly the cause of the complaint or appeal and must be filed with the Fair Office within 24 hours after the cause of the protest. If the Fair sustains the appeal, the fee will be refunded. The Fair reserves the right to cancel or combine classes as needed, as well as substitute judges. Classes may be combined or cancelled due to number of entries. If there is no competition in a class for two years, the class may be dropped. Unless participating in the on-going show, horses should be kept in the stall at all times except when permission is granted by the Superintendent (in situations such as colic, physical debility, nervousness or a cool-out period after a Western Games event). Horses should be neatly groomed and clean while on display to the public. Sweaty horses shall be brushed out properly. All tack is to be removed from the horse as soon as possible after the completion of classes. Blankets, hoods, leg wraps should be removed by 10 a.m. and may not be put back on until after 8 p.m. Whenever the exhibitor is leading the horse from the stall to the arena, they must be followed by a herdsman. The herdsman will be responsible to clean up any manure or shavings trailed by the horse, and to keep the public from following the horse too closely for safety.

FURTHER INFORMATION: The following information is provided to further clarify.

- **Height Specifications** - Horses - Over 54 inches high; Ponies - 54 inches and under; Miniature A – 34 inches and under, Miniature B – over 34 to 38 inches high.
- **Showmanship** - Score based on the following: Preparation of showing (35 percent) including condition of feet, condition of coat (freedom from scurf and dirt), cleanliness and grooming, score will be lowered for excess oil and use of objectionable materials, and trimming of ears, tail, etc.; Showing the animal (55 percent) including appearance of exhibitor, control of animal by exhibitor, poise of exhibitor, and skills in showing, including continuous attention, keeping the animal placed to advantage, and the ability to stand or move animal as requested by the judge; and fleshing or condition / thickness / distribution and texture of flesh (10 percent). The purpose of the showmanship contest is to create more interest in, and better knowledge of, proper grooming, training and showing animals. All training and preparation of the animals, both prior to and during show, is to be done by the contestants. Each contestant must show own animal. Showmanship will be judged PRIOR to the start of halter. Showmanship will not receive prize money awards.

PRIZE MONEY: Only animals listed in the Exhibitor's Guide will be accepted for prize money awards. For prize money, judge may or may not award all placings according to their discretion. Awards will be based on judges' records. Ribbons and tags shall not be considered proof for payment of prize money awards. Prize money will be forfeited by exhibitors failing to adhere to the release times printed in the Exhibitor's Guide (with the exception of a

vet's order or Superintendent's approval), by those failing to care for their animals, and by those failing to clean their stalls before leaving. Prize money checks for Open Horses may be picked up at the Livestock Office immediately prior to exhibit release. Checks remaining after October 31 and/or checks not cashed by November 30 will become forfeited and considered a donation to the SCF&EC. To clarify, the checks will not be considered "abandoned" property under Chapter 63.29 RCW, but will be a donation by the payee to the SCF&EC. Prize money checks will NOT be issued or re-issued after November 30. If you are unable to pick up your prize money check, you may mail the office a self addressed, stamped envelope with a request for us to mail your check. Prize money awards will be paid according to the following:

SPECIAL AWARDS

A rosette will be awarded to the Grand Champion and Reserve Grand Champion Mares (any age), Grand Champion and Reserve Grand Champion Geldings (any age), and the Grand Champion and Reserve Grand Champion Stallions (any age). Local ranches and breeders may have also donated other special awards. A list of such is available in the Livestock Office.

SUPERINTENDENT: Superintendent shall be in full charge of the department to which assigned and shall administer all policies pertaining to the respective department. Superintendent shall have charge of the entries, judge's sheets, and award sheets and shall be responsible for their being filled out correctly and returned to the Livestock Office. Superintendent has authority to discharge exhibits not meeting quality standards. Any questions pertaining to the Exhibitor's Guide or information contained therein shall be addressed by the Superintendent. Any protest regarding the duties of Superintendents, MUST be made to the General Livestock Superintendent.

ADDITIONAL FAIR INFORMATION: The east parking lot is only accessible with an appropriate parking pass. No person will be permitted to distribute advertising matter upon the grounds except from their place of business or exhibit space. No person shall distribute advertising matter upon the grounds, including, "For Sale" signs without Superintendent Approval. A "For Sale" bulletin board will be centrally located within each building / department for exhibitor use. The distribution of handbills, fliers, and heralds will not, under any circumstances, be permitted. Anyone violating this rule is subject to fine or expulsion from the grounds. Begging, soliciting, singing, and/or public speaking are prohibited. All concession space will be sold by the management and application must be made in writing. Under no circumstances will anyone be permitted to operate a concession without a signed agreement. 24-hour guard service is provided during the Fair. The Fair will use every precaution for safe preservation of livestock on exhibit, but will not be responsible for loss or damage. Spokane County Sheriff supervises police protection. Spokane Valley Fire Department supervises fire protection. Only seeing-eye dogs or dogs participating in an approved demonstration or commercial booth will be allowed on the grounds. Service animals trained for a specific service to aid the person they are accompanying will be allowed on the grounds. Companion animals will not be permitted. Smoking in the buildings and barns is prohibited. Alcoholic beverages are prohibited on the grounds except in the Beer Garden. To prevent the possibility of E-Coli, exhibitors are asked to not eat food in the barns. Exhibitors may not sleep in exhibit areas. The Spokane County Fair & Expo Center strictly adheres to Public Law 102-346 regarding animal protection. Copies of this law are available in the Fair Office and will be posted in appropriate places on the grounds. It is your responsibility to know and obey this law.

RIDING CLASS RULES

1. Exhibitor is required to read all rules found earlier in the Horse Department Exhibitor's Guide.
2. These events are **ONLY** open to exhibitors who have shown at least one animal in either halter or showmanship classes.
3. Exhibitors will be allowed to compete in the show that is held during their stay at the Fair **ONLY**.
4. Exhibitors will be allowed to compete on or with one horse per class. The same horse must be ridden in any event that has multiple go-rounds. No horse may be substituted with another. The same rider must compete in each go-round of a class that has more than one round. No rider substitutions will be permitted.
5. These classes are not associated with any breed scoring system.
6. Attire: Adults – Hats (or helmets) are encouraged. Safety helmets are required for participants under the age of 19.
7. Any tack failure that disrupts the class will result in a no score (or no time) for that class.
8. Bandages are allowed to cover up open leg wounds; **HOWEVER**, wrapping must be kept to a functional minimum. Artificial tails and braids are allowed. No horse will be penalized for tail carriage.
9. Unsportsmanlike conduct in the arena or anywhere on the grounds, i.e. profane language, unnecessary roughness, horse abuse, disorderly conduct. The competitor will be removed from competing, no warning is required. Action will be immediate.
10. A horse that is unmanageable or out of control will be disqualified for safety reasons.
11. All riders must remain mounted. Anyone becoming dismounted in an event or class will receive a no score (or no time) for that one class or event. If a horse falls during an event or class, a no score (or no time) will be given for that one class or event.

ADDITIONAL RULES / O-MOK-SEE

1. Tack: All riders must compete in western saddles, bridle, and bit. Skid boots, breast collars are allowed. Any other tack that is questionable, exhibitors are asked to receive prior approval from the Superintendent.
2. Attire: Contestants must wear riding boots, toe-heeled type, full-length pants, and shirt. Long-sleeved shirts are encouraged. Adults – Hats (or helmets) are encouraged. Safety helmets are required for participants under the age of 19. A mandatory warning is required before disqualification for dress code. No halter / bikini tops while riding in events.
3. Extra riding events will be held for adults after the O-Mok-See is completed if enough time remains.
4. Disqualifications will occur for any of the following:
 - A. Any infraction of the rules by the horse or rider.
 - B. Leaving the course, upsetting the start / finish line poles, or crossing the start / finish line outside of the poles. Horse and rider must remain in their own lane while competing in an event.
 - C. Hitting the horse with event properties, i.e. flag staff.
 - D. Intentionally striking the horse ahead of the elbow in any manner while on course (does not apply to petting).
 - E. Use of hot shots, bugs, etc. will result in immediate disqualification and expulsion from remainder of show.
 - F. Rubber banding feet into stirrups.
5. Rerides are to be run after the last rider in the event. Rerides will be permitted for interference by another rider and/or horse as determined by the judges, failure of all timing devices, other interference of the ride as determined by the judge. If a reride is given, the first time will not be announced until after the reride decision is made by the rider. If a course is moved for safety reasons in the middle of an event, riders may choose either to rerun or keep their first time (no-times will not be allowed to rerun). If the event is changed due to initial wrong measurements, all riders must reride.
6. Ties will be decided by a run-off. If the tie is in an individual event, the run-off will be run after the last rider for that event. If it is a tie for over all high point, then a coin will be flipped. The person who will call the coin will be the person with the lower rider number. The winner will be able to either pick to ride first or to pick the event to run. The other person will choose whichever was not picked by the winner of the coin toss.
7. Touching event properties with hands, with the exception of flags, will result in a 5-second penalty for every property touched.
8. The judge will signal with a green flag when the course is ready. If you cross the start line prior to the flag being given, you will receive a no time for that event. After being given the green flag, riders will have 60 seconds to start the event. If you do not start the event in the time allotted, you will be asked to leave the arena and will receive a no time for that event.
9. An exhibitor may use only one horse while competing in the O-Mok-See. In the High Point competition, awards will be given to the top three contestants in the following age groups: 19-29, 30-39, 40 and over. Points will be figured at 1st-100, 2nd-90, 3rd-80, 4th-70, 5th-60, 6th-50, 7th-40, 8th-30, 9th-20, 10th-10.

ADDITIONAL RULES / WESTERN PLEASURE AND EQUITATION

1. A Junior Horse is any horse that is 5 years and under. A Senior Horse is any horse that is 6 years and over.
2. Attire: Western riding boots, long pants (western style), and western long-sleeve shirt with collar, and hat or helmet. Optional attire includes spurs, chaps, vests or jackets. Judges may alter attire requirements due to weather.
3. Tack: Western saddle and western headstall. Bridle may be with a brow band, shaped ear or one ear. Martingales, tie-downs, draw reins, and cavason nosebands are prohibited. Bits – A Senior Horse must be shown in a standard western bit defined as having a shank with a maximum length overall of 8.5". The mouthpiece will consist of a metal bar 5/16" to 3/4" in diameter as measured one inch in from the shank. The bars may be inlaid but must be smooth or latex wrapped. Nothing may protrude above or below the mouthpiece (bar) such as extensions, prongs, or rivets designed to intimidate the horse. Rollers attached to the center of the bit are acceptable and may extend below the bar. Jointed mouthpieces are acceptable and may consist of two or three pieces and may have one or two joints. A three-piece mouthpiece may include a connecting ring of 1.25" or less in diameter or a connecting flat bar of 3/8" to 3/4" (measured top to bottom with a maximum length of 2"), which lies flat in the mouth or a roller or port as described herein. The port must be no higher than 3.5" maximum with roller(s) and covers acceptable. Jointed mouthpieces, half-breeds and spade bits are standard. Slip or gag bits, rigid donut mouthpieces and flat polo mouthpieces are prohibited. Roping bits with both reins connected to a single ring at center of cross bar shall not be used. Reins must be attached to each shank. Any rein design or other device which increases the effective length and thereby the leverage of the shank of a standard western bit is prohibited. A Junior Horse MAY be shown in a snaffle or hackamore, defined as standard snaffle bits as a center jointed single rounded, unwrapped smooth mouthpiece of 5/16" to 3/4" diameter metal as measured from ring to 1" in from the ring with a gradual decrease to the center of the snaffle. The rings may be from 2" to 4" outside diameter of either the loose type, eggbutt, dee, or center mounted without cheeks. The inside circumference of the ring must be free of rein, curb or headstall attachment hooks. If a curb strap is used it must be attached below the reins. Closed reins (example mecate) on a snaffle bit are prohibited. A hackamores includes a bosal rounded in shape and constructed of flexible braided rawhide or leather and must have a flexible nonmetallic core attached to a suitable headstall with maximum diameter of 3/4" at the cheek. Attached reins may be of hair, rope or leather. No other material of any kind is to be used in conjunction with a bosal, i.e., steel, metal or chains (exception: smooth plastic electrical tape is acceptable).
4. Gaits: The gates that will be required are walk, jog, and lope, reverse and back up. The judge has the ability to call for an extended jog if they feel it is needed to help them properly judge a class.

ADDITIONAL RULES / ENGLISH PLEASURE AND EQUITATION

1. A Junior Horse is any horse that is 5 years and under. A Senior Horse is any horse that is 6 years and over.
2. Attire: English riding boots, breeches, English riding jackets, appropriate under shirt, and top hat or helmet. Hair should be neat and contained. Judges may alter attire requirements due to weather.
3. Tack: English saddle and pad, appropriate English bit and full bridle.
4. Gaits: The gates that will be required are walk, trot, and canter, reverse and back up. The judge has the ability to call for a hand gallop, dropping your stirrups, picking up your stirrups, or "on the buckle" if they feel it is needed to help them properly judge a class.

ADDITIONAL RULES / TRAIL CLASS

1. Attire: Either English or Western attire is permitted. See English or Western performance sections for details (above).
2. Tack: Either English or Western tack is permitted. See English or Western performance sections for details (above).
3. All competitors have three chances at any one obstacle. After that you will receive a zero for that obstacle and will be asked to move onto the next obstacle.
4. Obstacles: There are many obstacles that may be used including, but not limited to, gate, cavaleties / poles on the ground, backing through obstacles or shape, serpentine obstacles, carrying objects, bridge, mailbox, putting on / removing rain slicker, side passing, spinning in box, ground tying.
5. Please take the time to practice these obstacles and train for this class prior to arriving at the Fair.
6. Gaits that will be required are walk, trot, and lope. In-hand contestants will be required to walk and trot.
7. No competitor may cross-enter the same horse in both mounted and in-hand trail.

ADDITIONAL RULES / LUNGE LINE CLASS

1. Attire: Either English or Western attire is permitted. See English or Western performance sections for details (above).
2. Tack: Halter and lunge line (not to exceed 30 feet in length). A lunge whip is optional.
3. Gaits: Walk, jog/trot, and lope/canter.
4. Animals will be scored on movement, manners / expressions / attitude, conformation, and use of the circle.
5. The exhibitor is given 90 seconds to show all three gaits in both directions. You will be given an announcement of "HALF" at the 45-second mark. Any movements done after "TIME" has been called will not be calculated in the judge's score.
6. After "TIME" has been called, if your horse has not already been stopped, halt your horse and set them up for inspection. The judge at this time will do a conformation inspection on your horse. This score will also be calculated into your overall score.
7. Disqualifications include a horse that falls, striking the horse with either the lunge whip or the lunge line, a horse stepping over or getting tangled in the lunge line, and/or a horse that becomes loose in the arena.

ADDITIONAL RULES / NOVICE REINING CLASS

1. Attire: Standard Western attire is permitted. See Western performance section for details (above).
2. Tack: Standard Western tack is permitted. See Western performance section for details (above). Optional equipment includes skid boots, bell boots, etc.
3. Closed reins are not allowed except as standard romel reins. All riders are encouraged to ride with one hand on the reins, however if you do need to ride with two hands to maintain control you will be allowed to.
4. The pattern will be posted the night before at both the arena announcer's booth and the information board at the end of Barn C.
5. Required maneuvers will include, but are not limited to, left-hand circle, right-hand circle, lead change, right-hand spin, left-hand spin, controlled stop / sliding stop, reverse of direction / roll back.
6. This class is to help people that have recently started reining learn what areas they can improve on and what areas they are doing well. If you have any other questions, please contact Andrew Tate at sifomoksee@yahoo.com. Please remember that this is a beginner's class and all competitors will be considered novice riders.

SHOW RING ETHICS

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit prize money, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada. The following is a list of guidelines for all exhibitors and all livestock in competitive events.

1. All exhibitors must present, upon request of the Fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. All treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian any time after an animal arrives on the Fair premises.
5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Assn of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

HERDSMANSHIP CONTEST

The purposes of the Interstate Fair's Herdsmanship Contest are to educate the public on livestock and encourage exhibitors to care for animals, pens and equipment. The Fair revised the Herdsmanship Program in 2007 asking exhibitors to put an extra emphasis on educating the public through posters and/or creative displays. Exhibitors must receive a minimum cumulative score of 80% or better to be eligible to receive herdsmanship awards. Scores will be posted daily in each department.

1. In order to be eligible for Herdsmanship, exhibitor's must have the following -
 - a. Educational Display or Poster.
 - b. Stall / Coop Card displayed for each animal.
 - c. Animal must be shown in a class and not at the Fair for display only.
 - d. Clubs / Chapters must also have a banner displayed in their area.
2. All work is to be completed by the exhibitor. Judges will be instructed to disqualify entries if adults are completing the work for youth exhibitors with the exception of Friday and Monday prior to 4:00 p.m.
3. Displays are to be in place by 10:00 a.m. the morning after each department has arrived at the Fair. Signs, curtains, banners and any other decorations or displays should be attached securely to the stalls or supports but not in a manner that might pose a threat of injury to the animal occupying the area, such as wire ends or anything else protruding into the pen / stall / cage. Displays should not interrupt the smooth operation of the stall door rollers, pen gates, or cage doors.
4. Banners and cash prizes (\$25.00 first / \$15 second / \$10 third) will be given to the highest total for each Adult Division in each species. Banners and cash prizes (175 points first / 100 points second / 75 points third) will be given to the highest total for each Youth Division in each species.
5. Herdsmanship Awards will give given in each department in the following divisions -
 - a. Five or more animals of a species.
 - b. Less than 5 animals of a species.
6. Should any questions arise regarding judging, exhibitors and/or superintendents must direct their comments / concerns to the Fair Coordinator, Jessie McLaughlin.
7. Judging will occur twice daily. *If exhibitors are present during the judging and can answer a bonus question given by the judge, they will receive up to 10 additional points. The criteria is as follows:

5 points	Housing - Tack and Equipment
10 points	Animals - Clean
10 points	Animals - Food and Water
5 points	Animals - Content / Happy
5 points	Overall Appearance - Organization

5 points	Overall Appearance - Decorations
15 points	Education - Overall Display
15 points	Education - Accurate Information
5 points	Education - Incorporates Fair Theme
100 points	TOTAL SCORE*
