

INTERSTATE FAIR AMBASSADOR INFORMATION AND RULES

Every Interstate Fair Ambassador becomes a representative of the highest ideals of the people of Spokane County. What is said or done is magnified many times, for good or bad. The simple rules listed below have been developed from many years of experience to make each Ambassador's task a pleasant one. When serving as an Ambassador and participating in official capacities, the Ambassadors' time will be organized by Interstate Fair personnel. The Ambassador Program will be coordinated this year by Jessie McLaughlin at 477-2772.

Along with the honor of being selected as an Interstate Fair Ambassador, there are certain obligations and rules to be followed.

1. Each Ambassador must be at least a junior in high school and no older than 20 years of age at the time of the competition.
2. Each Ambassador must be single throughout the reign as Interstate Fair Ambassador, never have been married, divorced or had a marriage annulled. It must be understood also that contestants entering the pageant cannot have been pregnant, have a child, or become pregnant during their reign.
3. Entrant must never have been convicted of a felony offense.
4. Public appearances, publicity, endorsements, gifts, photographs, etc. must have the specific approval of the Interstate Fair Management prior to any commitments.
5. Appearances at the Fair will include, but are not be limited to, the following: Meet and greets at the gate, celebrity introductions, newsletter distribution each morning, special contest hosts, assistants to family entertainers, and photography sessions throughout the duration of the Fair at concerts, rodeos, flag ceremonies, grand opening exercises, and special booth award presentations. Applicants that have personal beliefs that would prevent them from attending or participating in any of the Fair activities listed above should not apply.
6. While serving in official capacities, your activities and time will be organized by Interstate Fair personnel. Ambassadors and their family members will be expected to cooperate with Fair management, staff, chaperons, and designated persons in charge of official Fair activities. Official Fair appearances by Ambassadors will be chaperoned.
7. As an Ambassador, you must be available to serve as the official host of the Fair, September 5-14, 2014. Please minimize all outside commitments during this period. Ambassadors will be permitted to miss three full days or six half days (half days are defined as 9 a.m. to 3 p.m. and 3 p.m. to approximately 8 p.m.). Ambassadors **MUST** be on time for their duties. Ambassadors unable to meet the above requirement will forfeit their scholarship.
8. While at the Fair or participating in Fair-related activities, Ambassadors will not smoke substances of any kind, chew tobacco or drink alcoholic beverages. Also, chewing gum is an activity that must be limited to times when you are not in the public eye. The use of cellular phones, electronic devices such as tablets, and sunglasses, as well, will be allowed only during times when you are not in the public eye. Visible body piercings must be removed other than earrings. Tattoos, if any, must be completely covered.

9. Family members and friends will not be permitted to accompany Ambassadors while they are performing their responsibilities as Ambassadors to the Fair.
10. Courtesy and respect should be practiced at all times. Our goal is to have a positive experience for the public and the Ambassadors. Ambassadors are highly visible and comments from the public reflect on them in particular and on the Fair, as well as the County of Spokane.
11. The Fair will furnish a portion of the clothing required as an Ambassador. The Ambassadors are required to keep their Fair wardrobe ready and available at all times. The schedule may call for you to change outfits several times each day. Clothing will be worn in the style determined by Fair Staff; clothes may not be altered unless prior approval is received from Fair Staff. The Interstate Fair will provide a suitable and secure changing facility, as well as a schedule of attire to the Ambassadors - noting that there may be some changes as the Fair proceeds. Ambassadors will provide their own comfortable walking shoes. Open-toed shoes, sandals, flip-flops, and thongs will not be permitted. The Ambassadors following successful completion of their responsibilities may keep clothing provided by the Fair.
12. Upon successfully completing the duties as an Ambassador of the Fair, each Ambassador will receive a \$500.00 scholarship that will be sent to the educational institution of their choice and may be used for tuition as well as books. The scholarship must be used within two years or must be returned to the Spokane County Interstate Fair.
13. Ambassadors will also receive up to \$75.00 just prior to the Fair as a food allowance. The allowance, or portion thereof, will be awarded if the Fair is unable to find vendors to host lunch and dinner throughout the ten days of the Fair. Ambassadors will be expected to report to the Fair each morning having already had a good breakfast.
14. Ambassadors will also be required to assist with the 2015 Ambassador competition slated for March 2015. Duties would include recruiting applicants, acting as Master of Ceremonies during the competition, delivering a "farewell" speech of approximately five minutes, and recruiting a sponsor / supporter for the program.
