

Meeting Notice

A meeting of the WRIA 54 Lower Spokane River Watershed Planning Unit will be held at:

Date: Wednesday June 28, 2006
Time: 6:00 am – 8:00 pm
Place: Lakeside High School Cafeteria
5909 Highway 291, Ninemile Falls, WA 99026 (509) 340-4219

Directions: Lakeside High School is located in Suncrest, on the shores of Lake Spokane (Long Lake), 14 miles northwest of Spokane, WA. Enter the main building of the High School and turn right. The cafeteria is located across the hall from the library.

From Spokane: Travel west on Francis Ave, which will become Highway 291 (Nine Mile Road). After passing the Nine Mile Dam, continue about 3.5 miles up “Big Sandy Hill” to Suncrest. Lakeside's entrance is the first left at the top of the hill. After turning into the entrance, turn left again into the second driveway and into the parking lot.

Traveling From Highway 395 North: Turn left at Clayton onto Williams Valley Road. Continue south on Williams Valley Road for 6 miles. Turn left at the stop onto Burroughs Rd. In approximately 1 mile, turn right (south) onto Swenson. Follow Swenson 6.4 miles over the hills to Highway 291. Lakeside High School is located across Highway 291 at the Swenson Road intersection.

Traveling From Highway 2 North: Travel south through Chattaroy. The next intersection after the highway expands into a 4 lane divided road is the Dennison-Chattaroy Road. Turn right (west), continuing to Highway 395. Cross the highway; the road changes names to Staley. Continue several miles (through Monroe stop sign) to Swenson Rd. Turn left (south) onto Swenson, traveling approximately 4 miles to Highway 291. The High School is located across Highway 291 at the Swenson Road intersection.
