

## SEPA CHECKLIST REQUIREMENTS

1. Tax Parcel Number: A tax parcel number must be included along with a description of the location of the property. This can be obtained from your real estate tax statement or from the Spokane County Assessor's Office at 477-3698. If you are unable to provide the tax parcel number, please include a legal description of the property.
2. Site Plan: Include a complete site plan of the project showing the location of the development or project, dimensions, cross sections, materials and topographical information if it is available. The site plan must be neat and easy to read, it does not have to be professional quality, a detailed hand sketch will work.
3. Vicinity map: Include a map of the general area showing the boundaries of the parcel the project is proposed to occur on. An assessor's map, section map, plat map or other area map will be adequate for this purpose.
4. Fees: A fee of \$96.64 must be submitted with your Environmental Checklist. Checks should be made out to Spokane County.
5. Completeness of checklists and checklist legibility: We request that all questions in your checklist be answered completely and thoroughly. Do not leave questions blank. If a question does not apply to your project, please include "N/A" as a response, or if you do not know the answer to a question, respond "unknown". Checklists must be readable with typing preferred. Printed or neatly written material is also acceptable. If your checklist is difficult to read, or questions are left unanswered, your checklist may be returned to you, causing delays.
