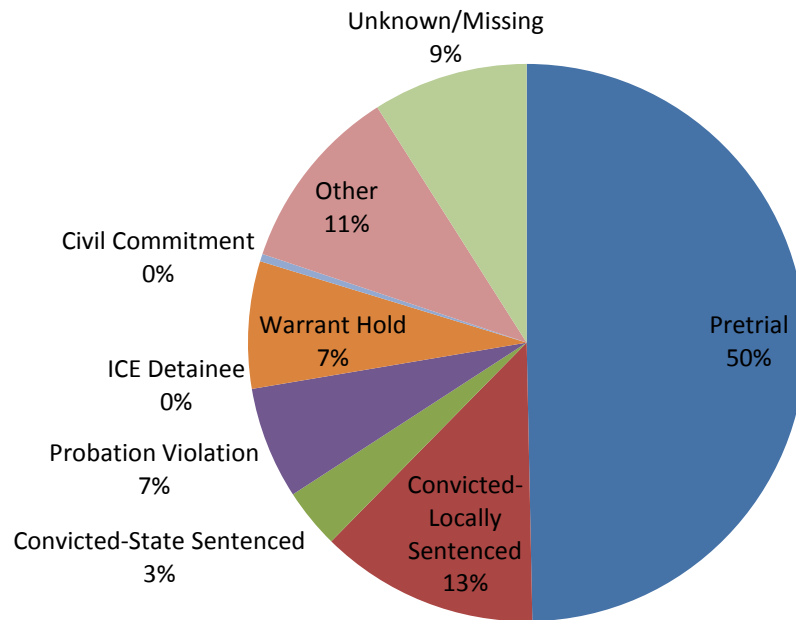

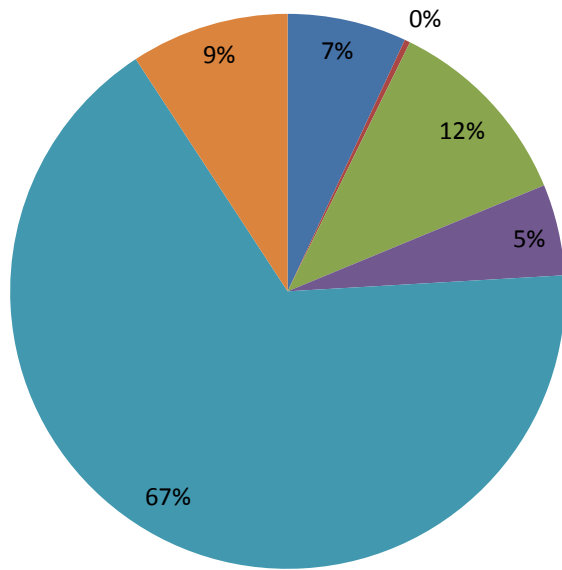

Jail Population by Legal Status, 2014

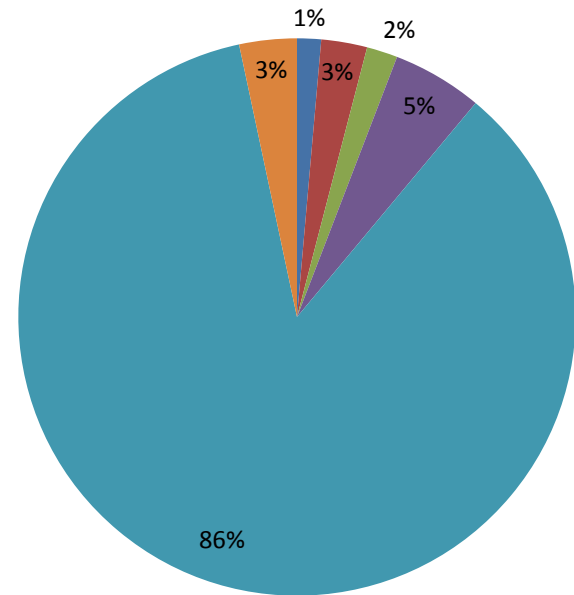


Jail vs. County Population by Race

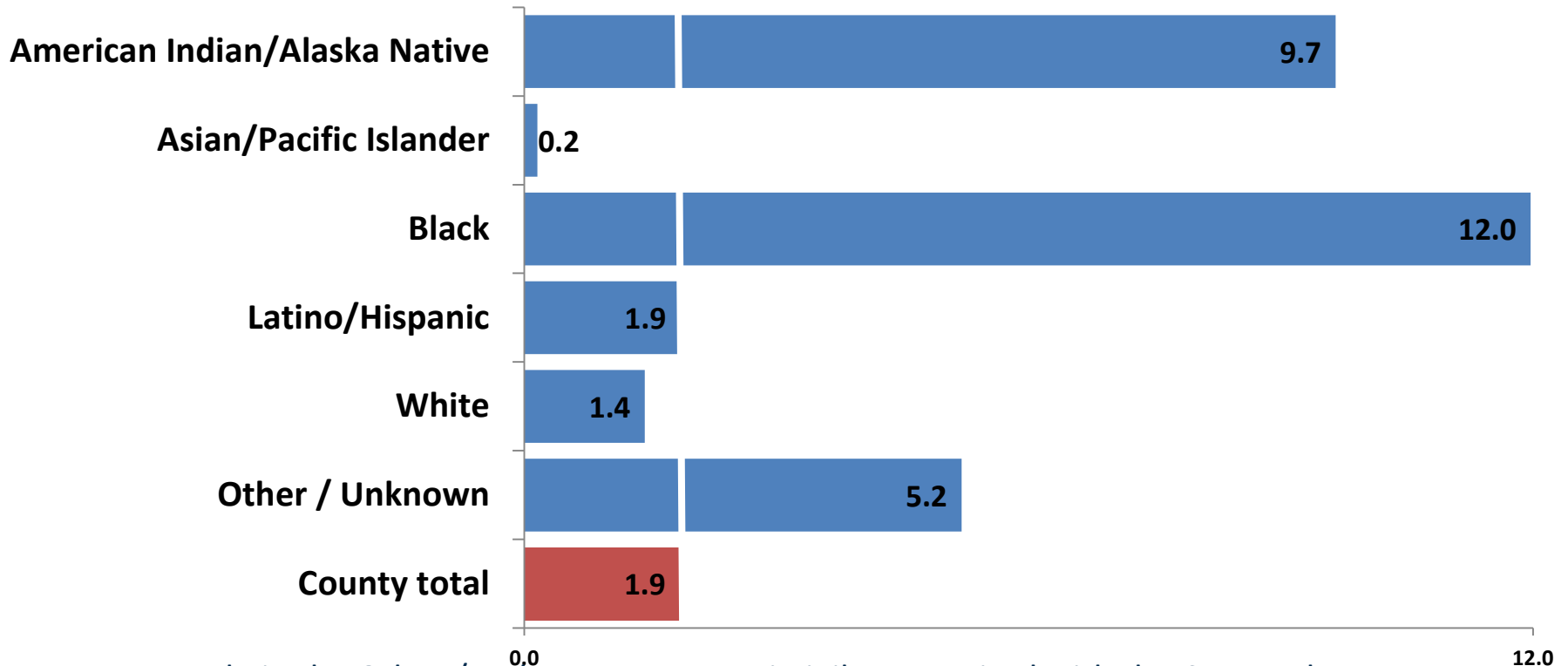

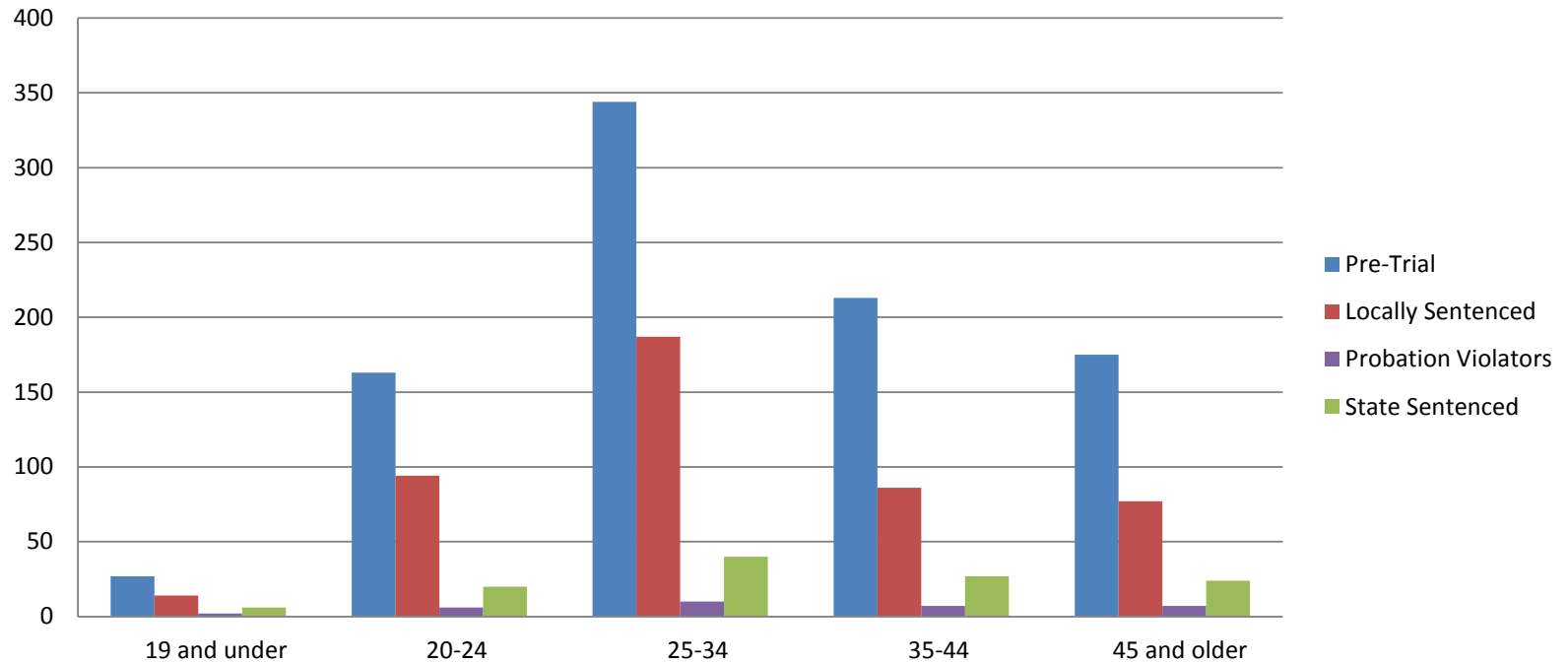
Jail Rate per 1,000 Spokane Residents in 2014



Note: People in the Other / Unknown category in jail were paired with the Census data on Multi-Racial residents for the purpose of analysis.

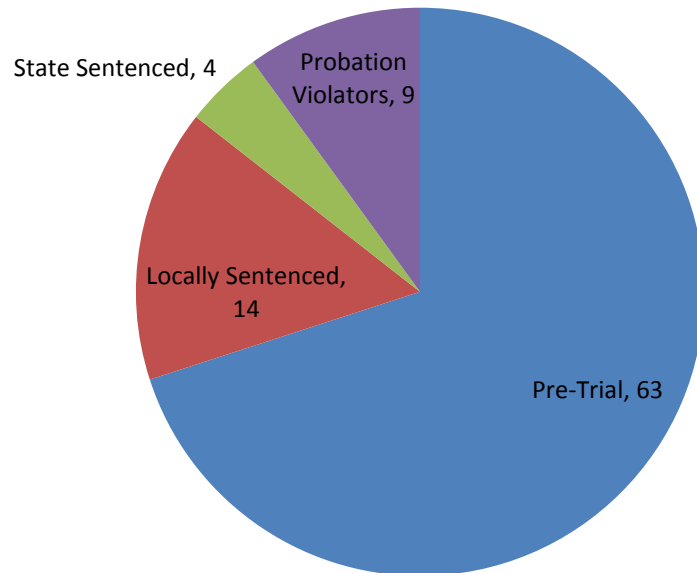

Jail Population Age by Confinement Type, 2014

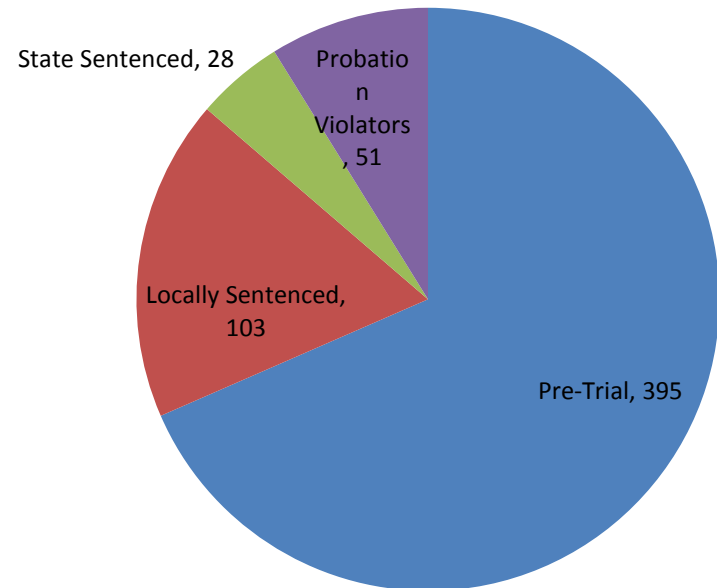

Female Confinement, 2014

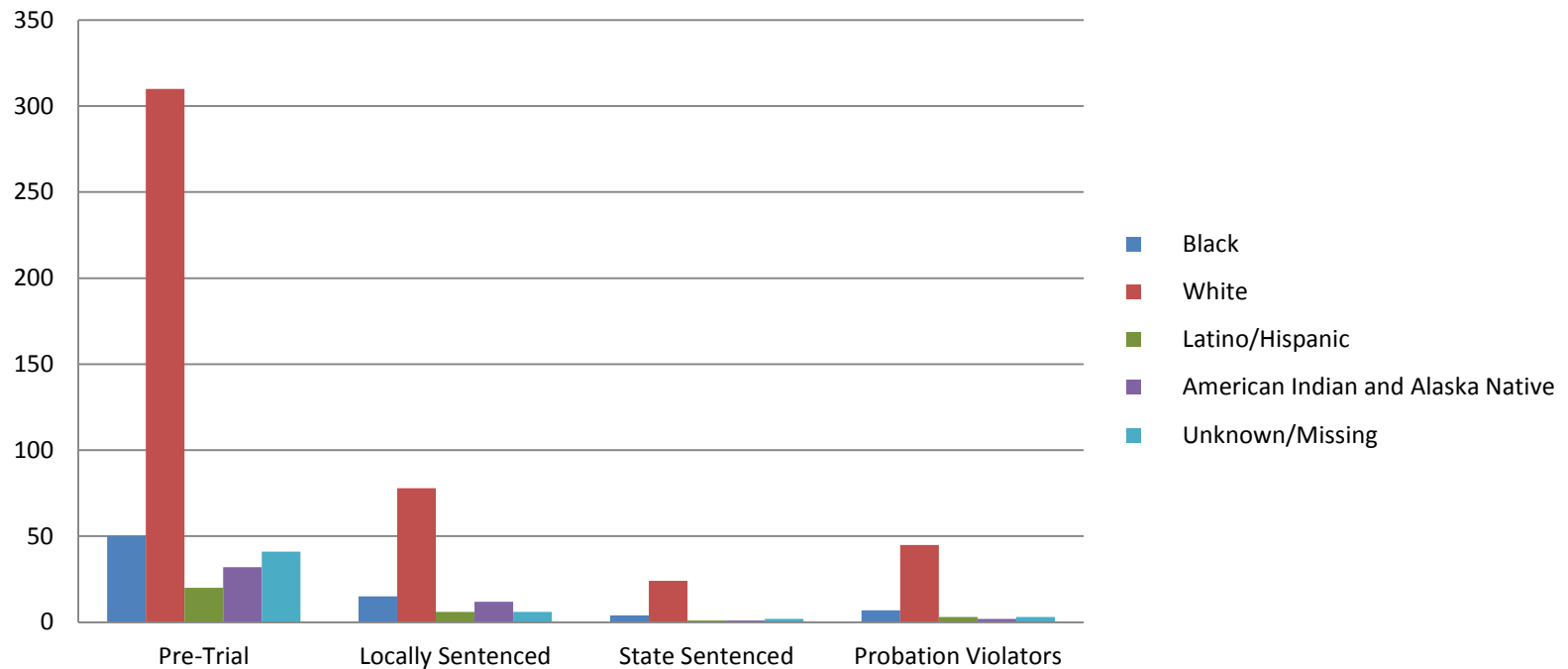


Male Confinement, 2014



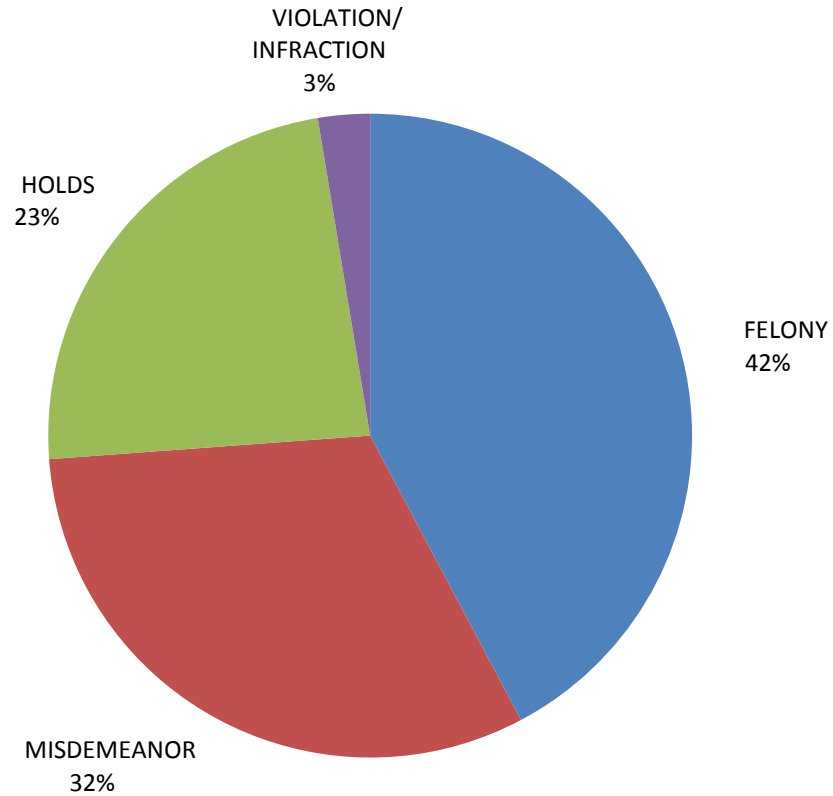

Jail Population Race by Confinement Type, 2014

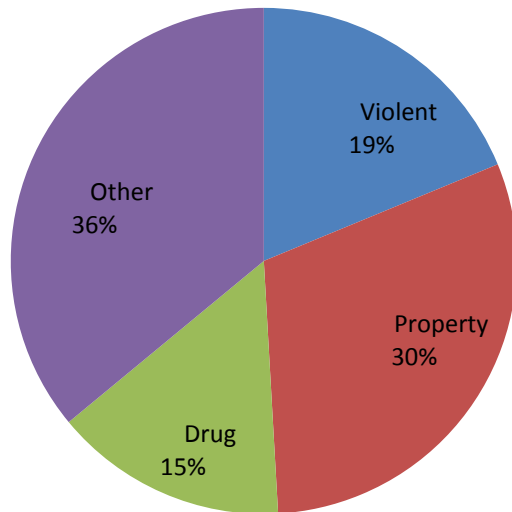

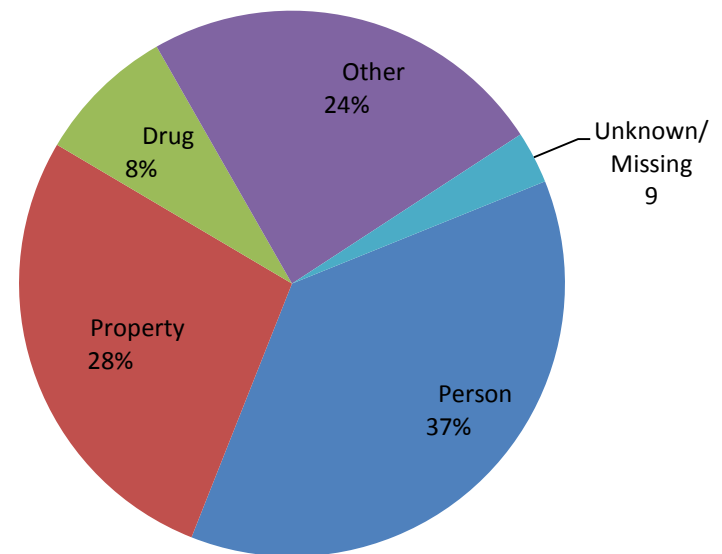
Confined Population by Charge Severity, 2014



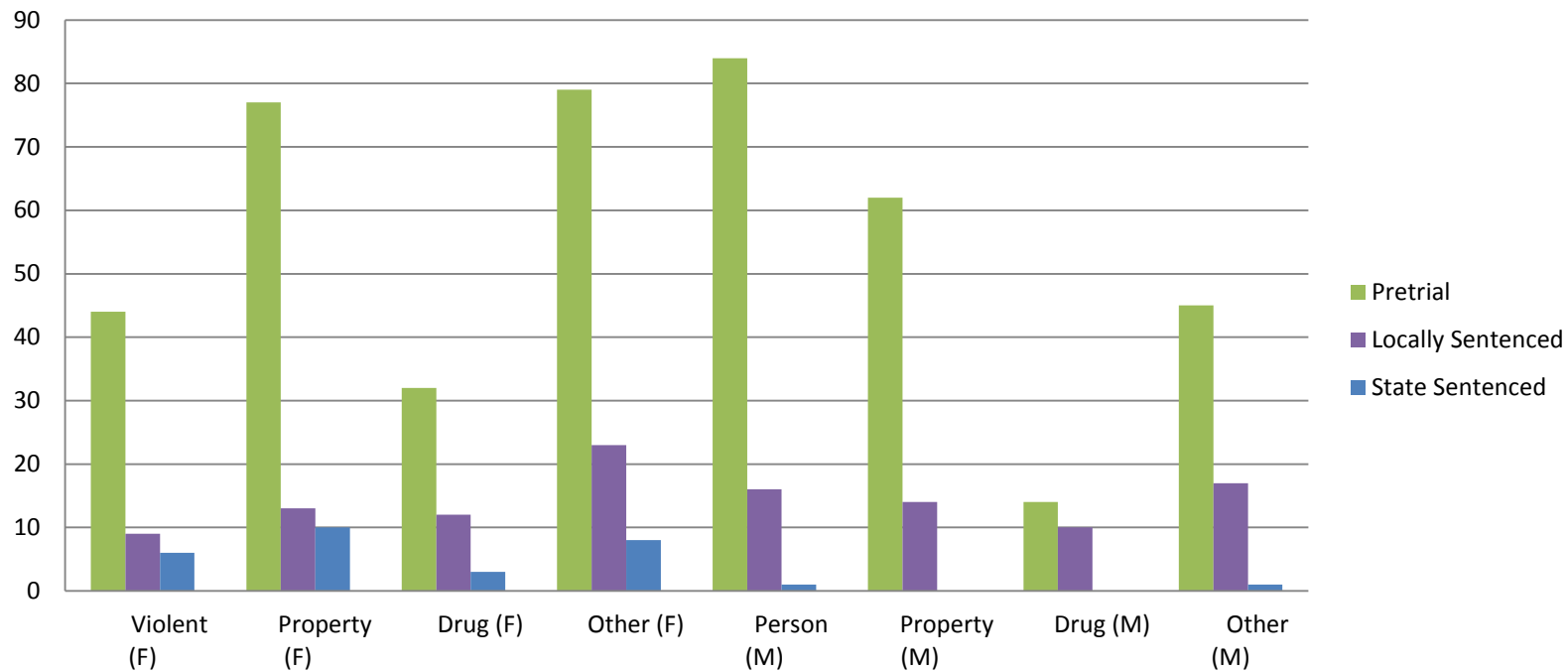
Confined Population by Felony Charges, 2014



Confined Population by Misdemeanor Charges, 2014



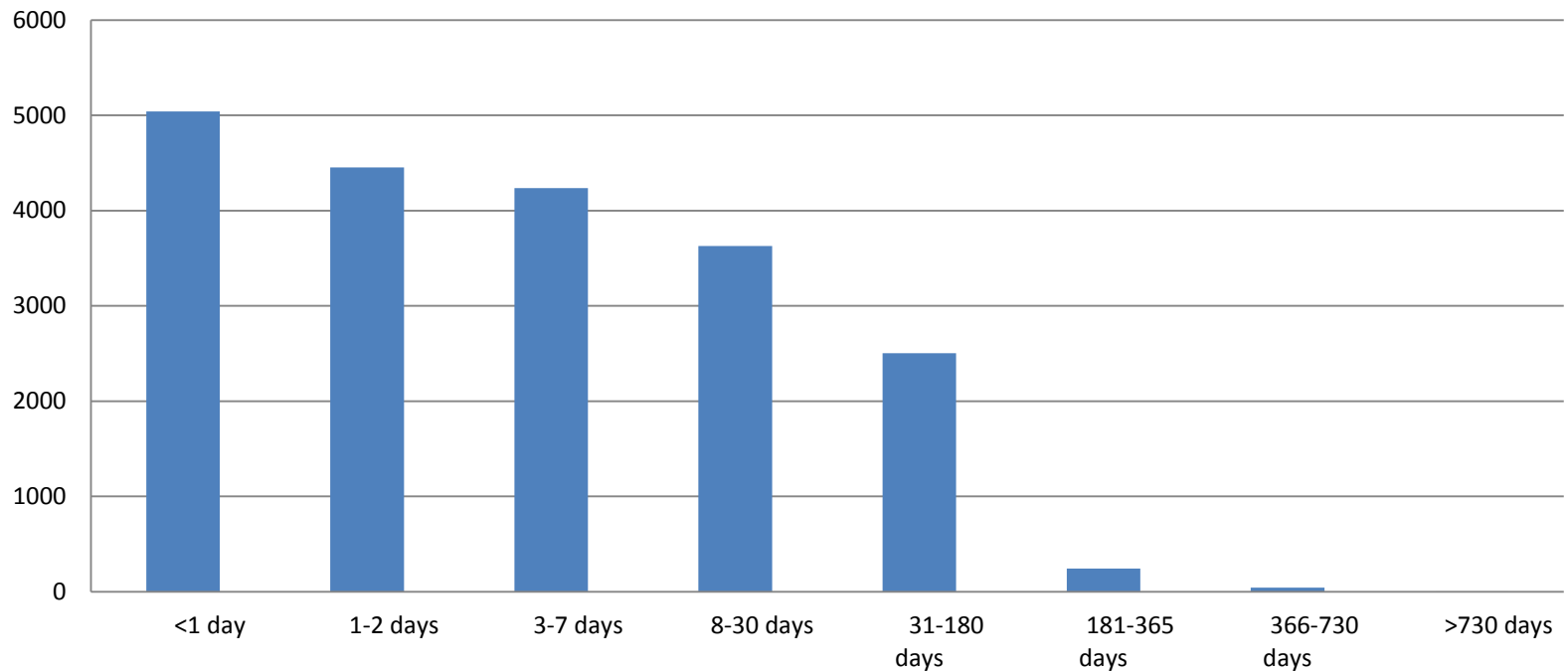
Offense Charges of Jail Population by Confinement Type, 2014

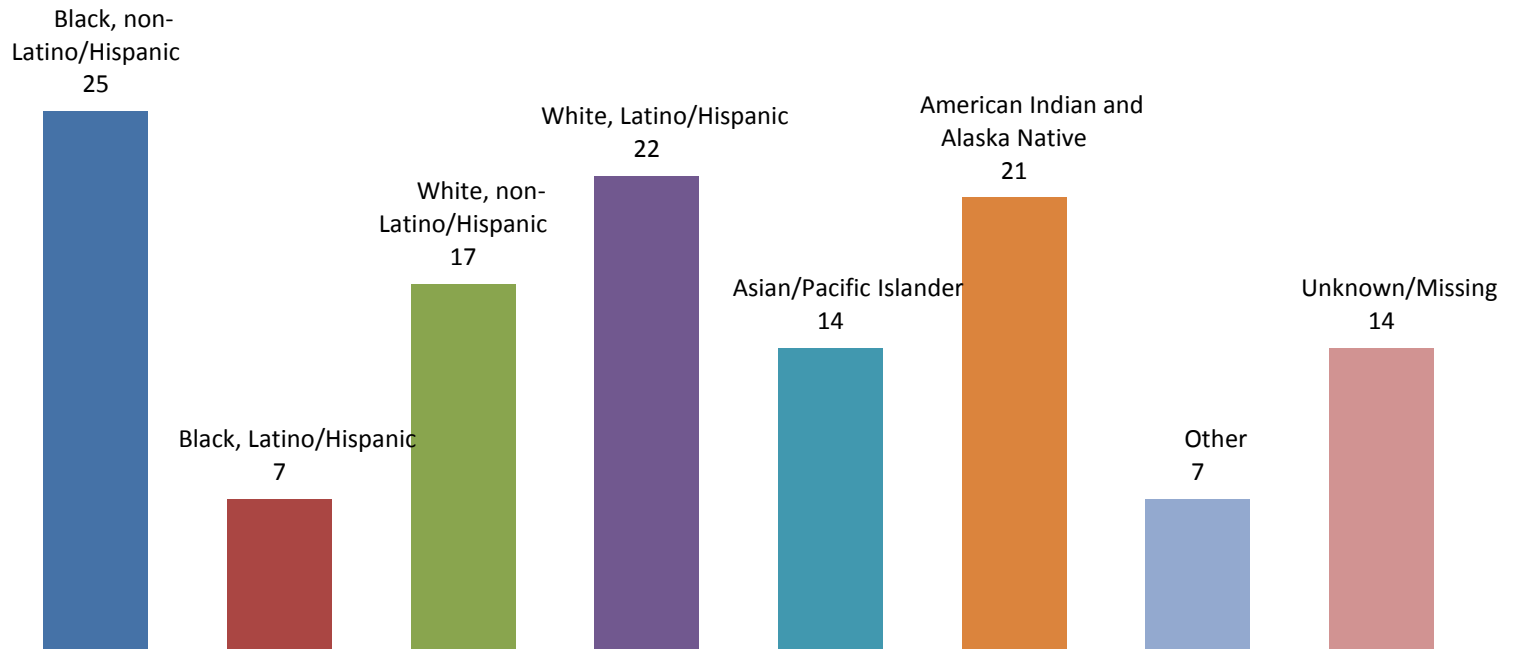

Length of Stay at Time of Release, 2014



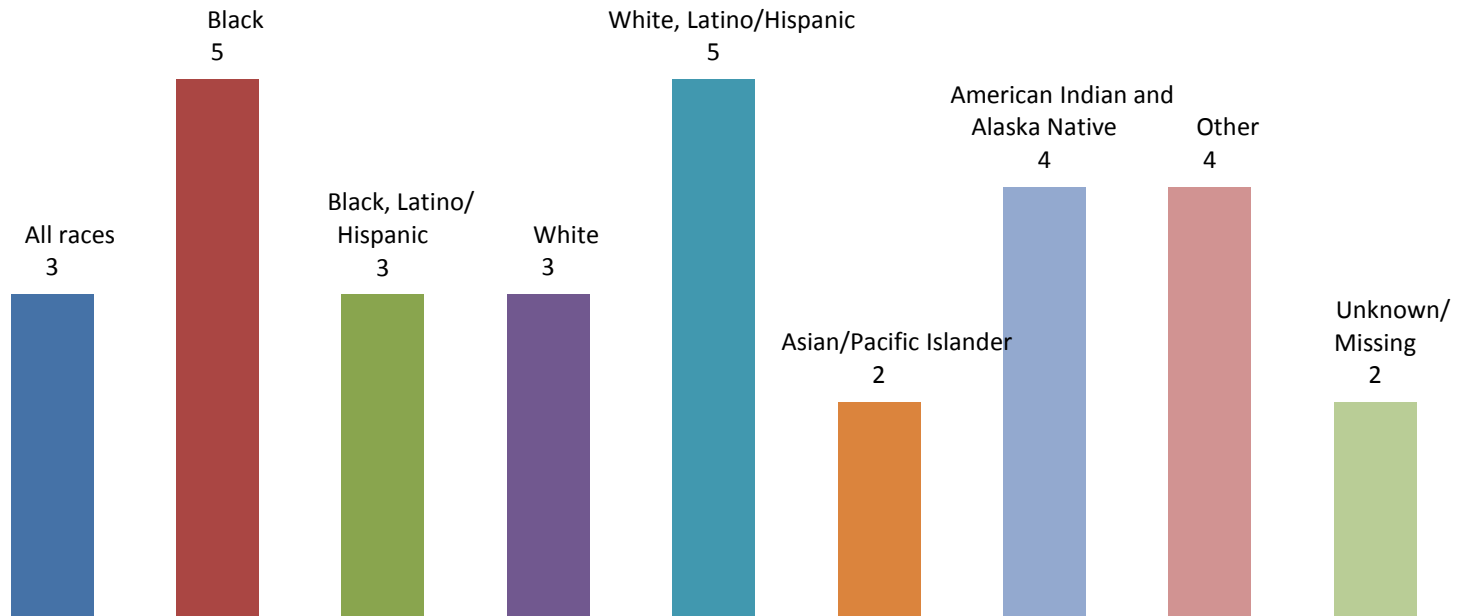

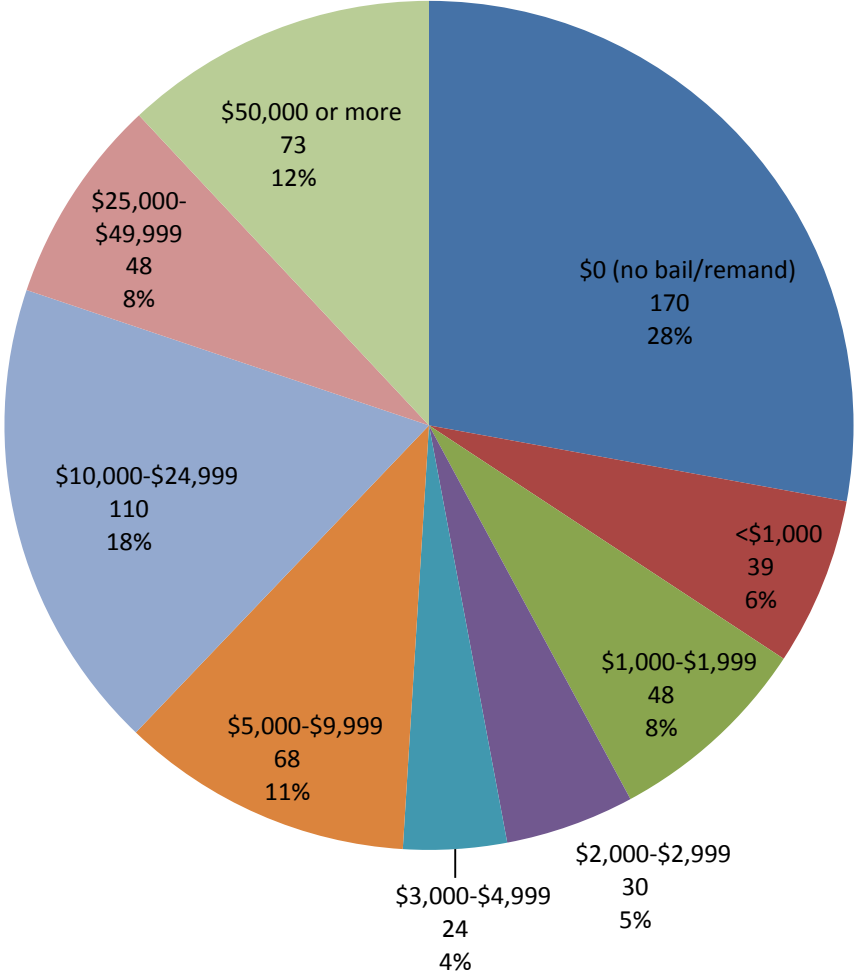

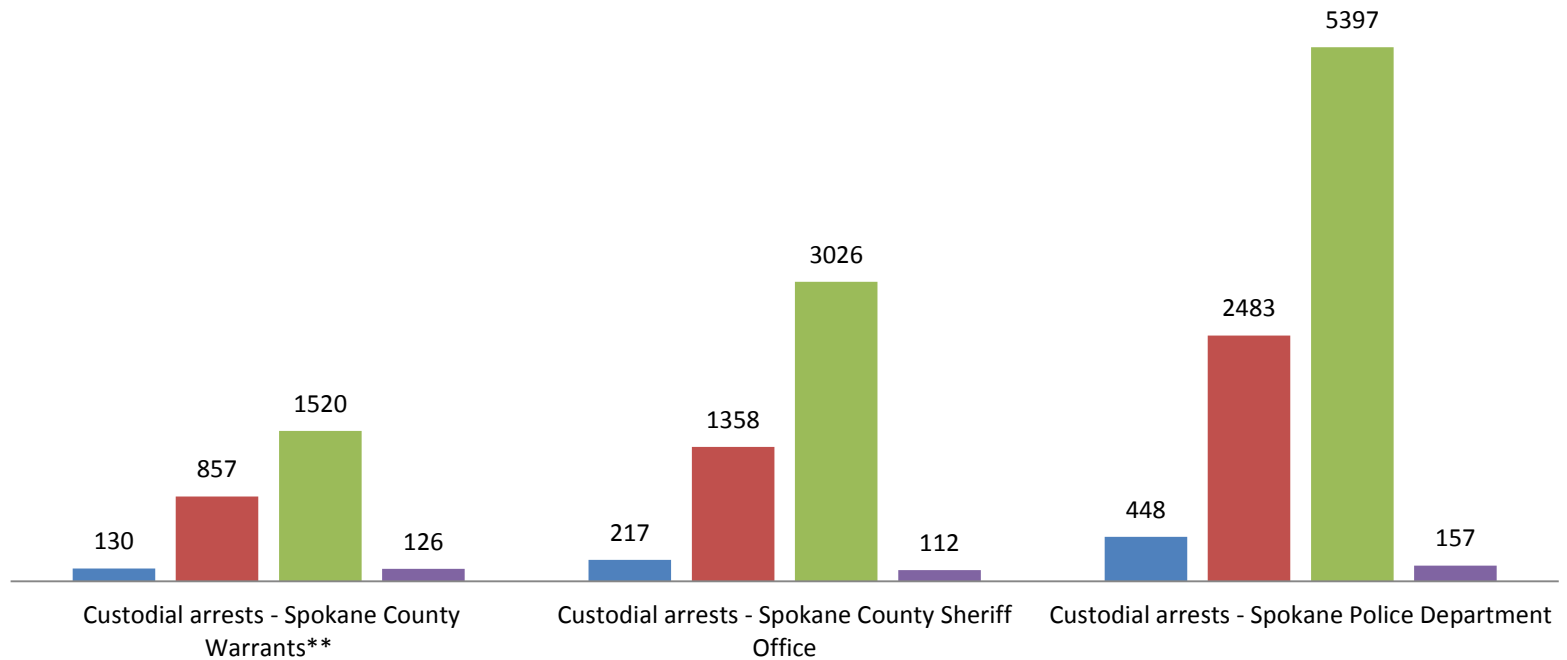

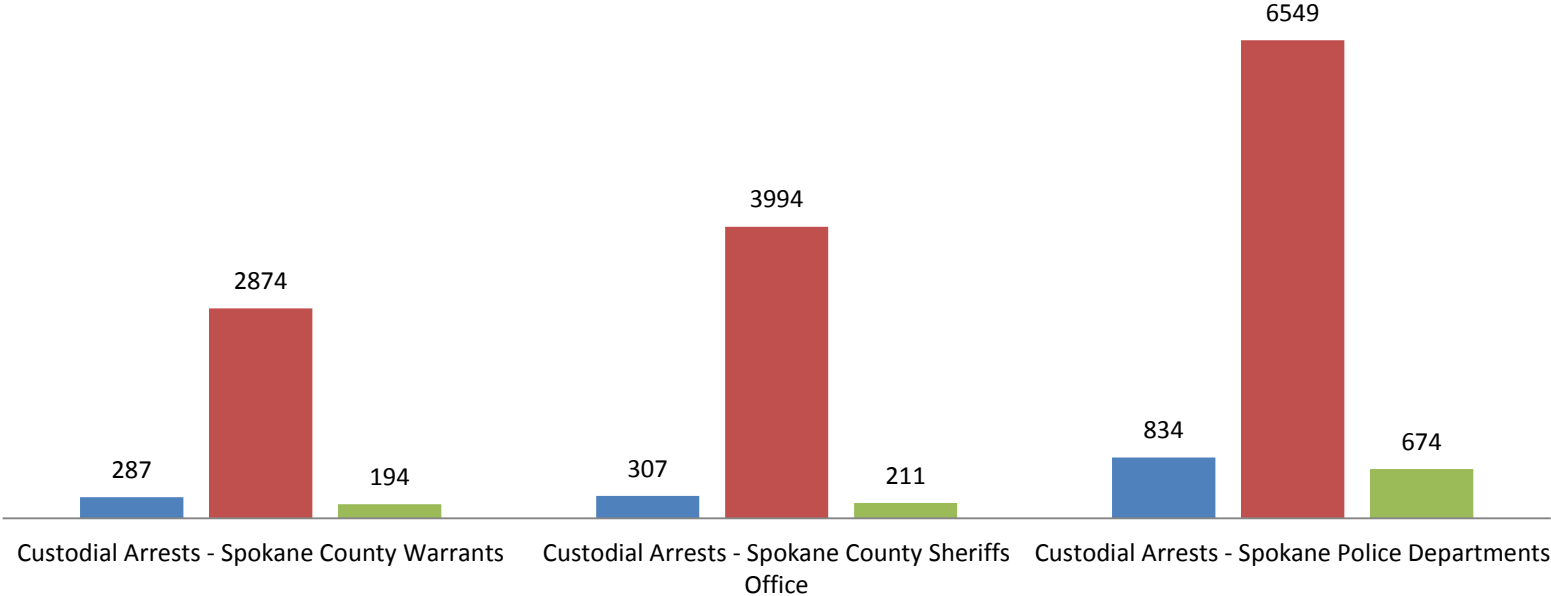

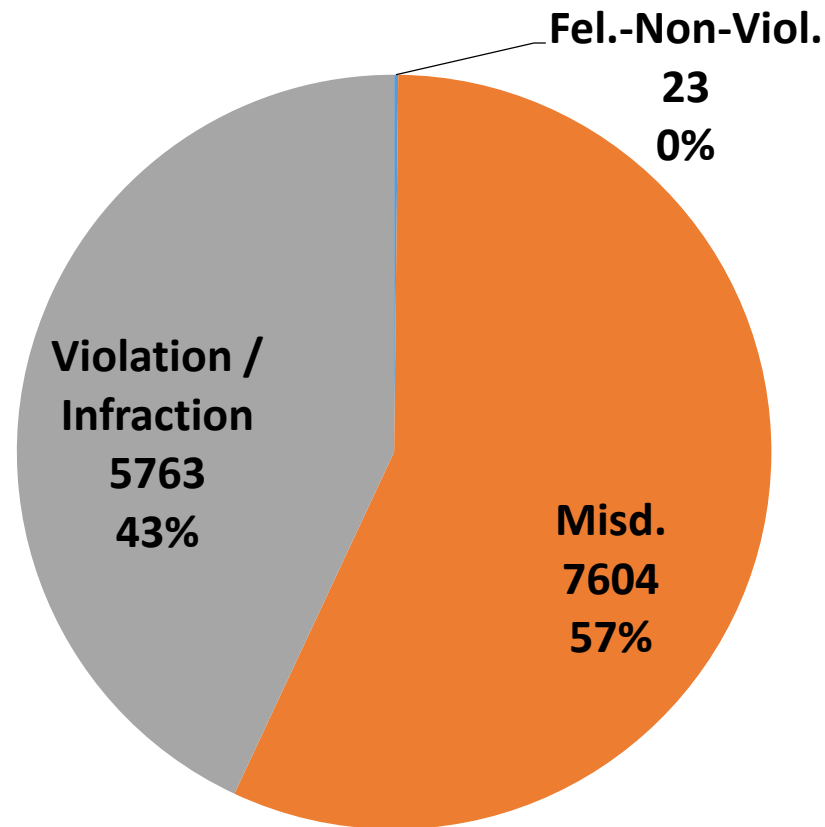

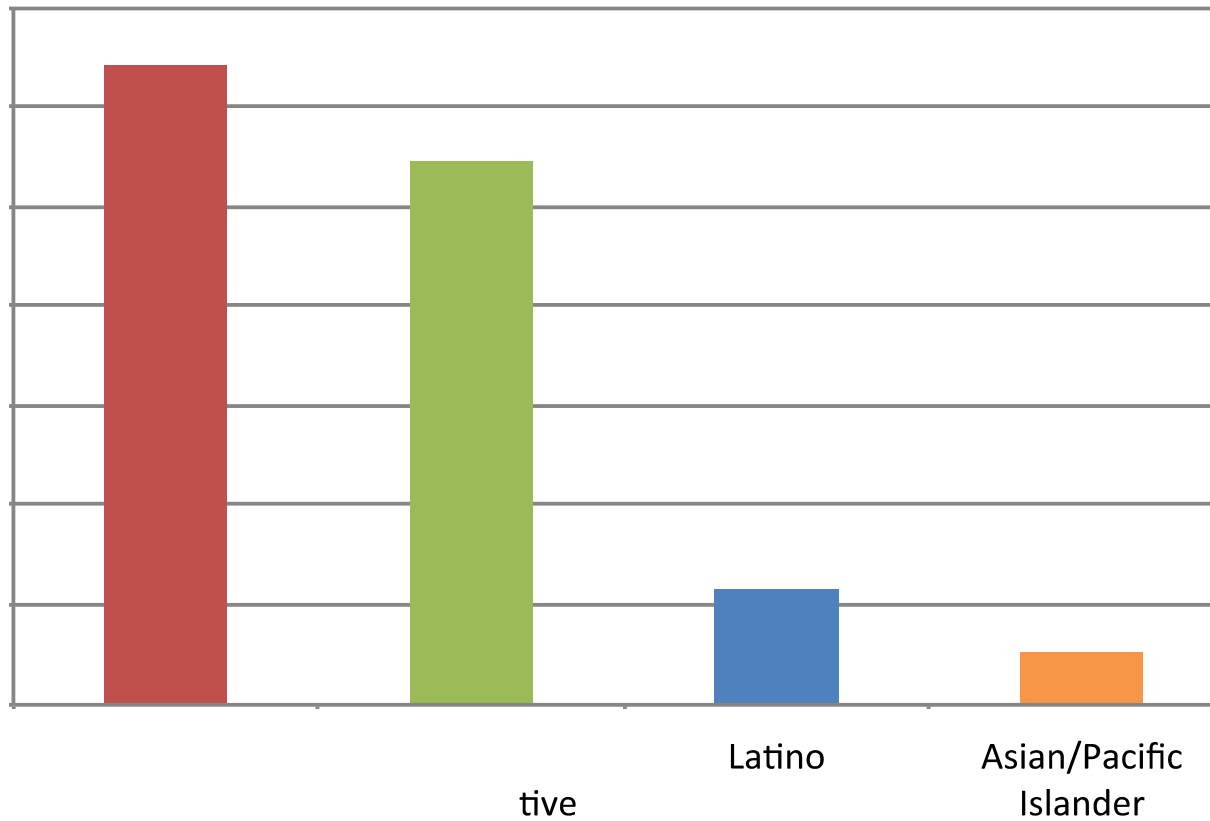
Non-custodial Arrest by Charge (2014)



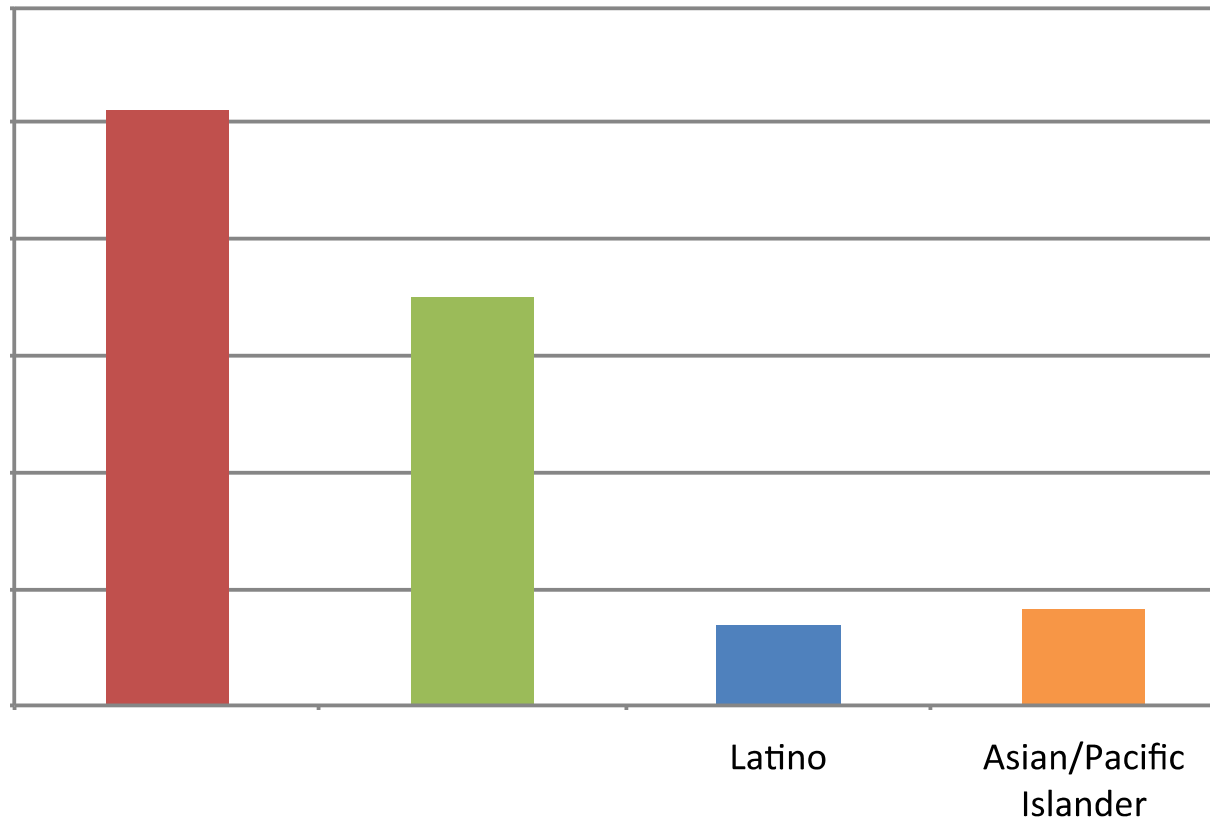

Relative Rate Index



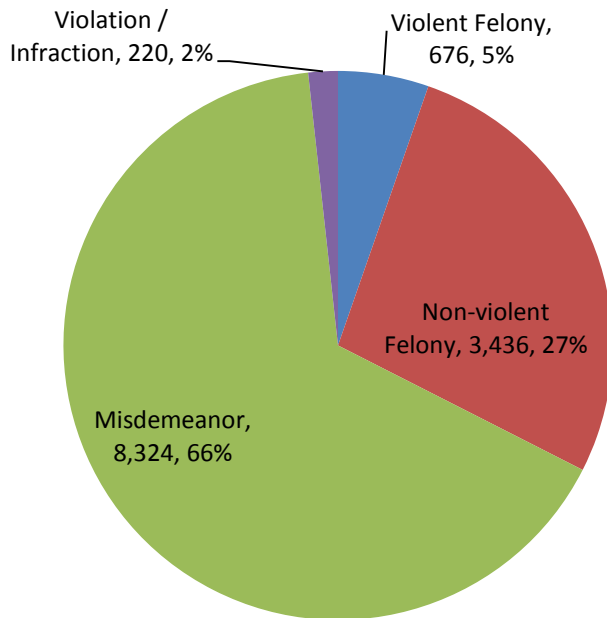
Non-Custodial Arrests 2014 Relative Rate Index

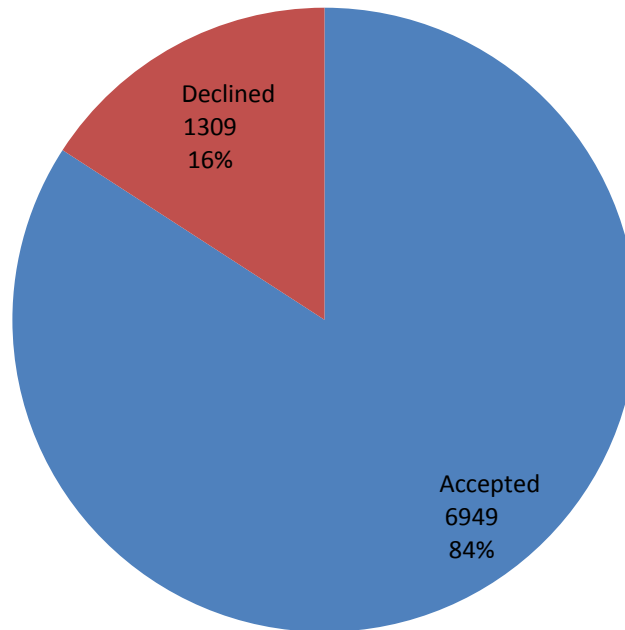


% of cases accepted by prosecutor:

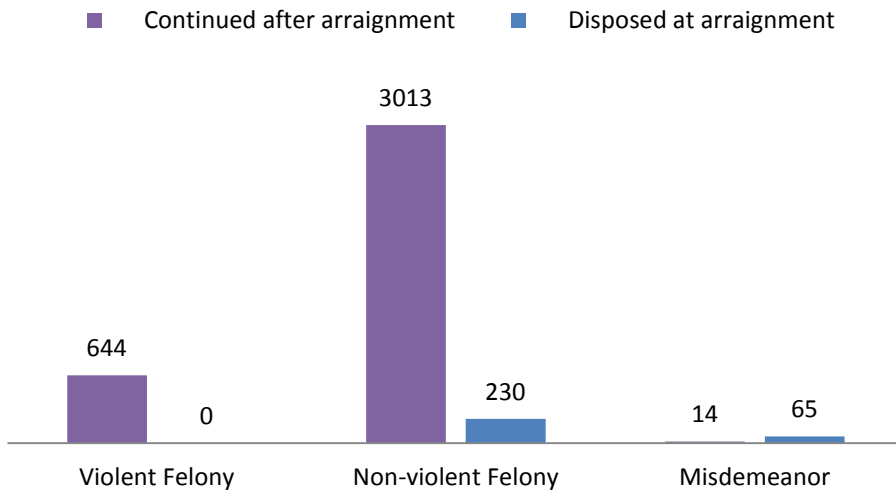
Total Number of Misdemeanor Cases Received by the Prosecutor



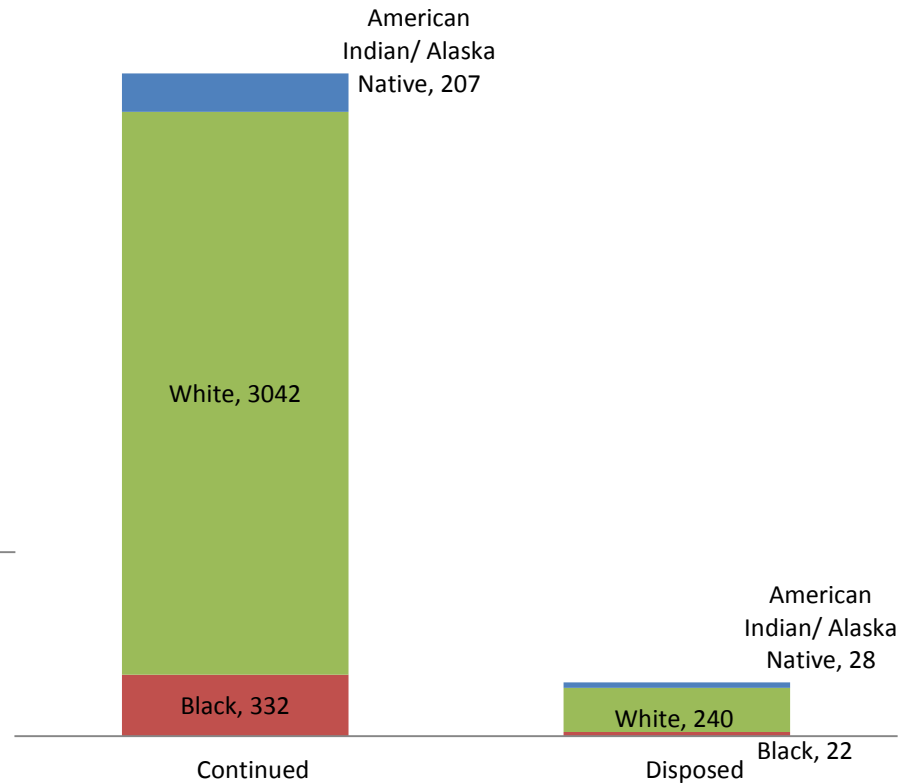

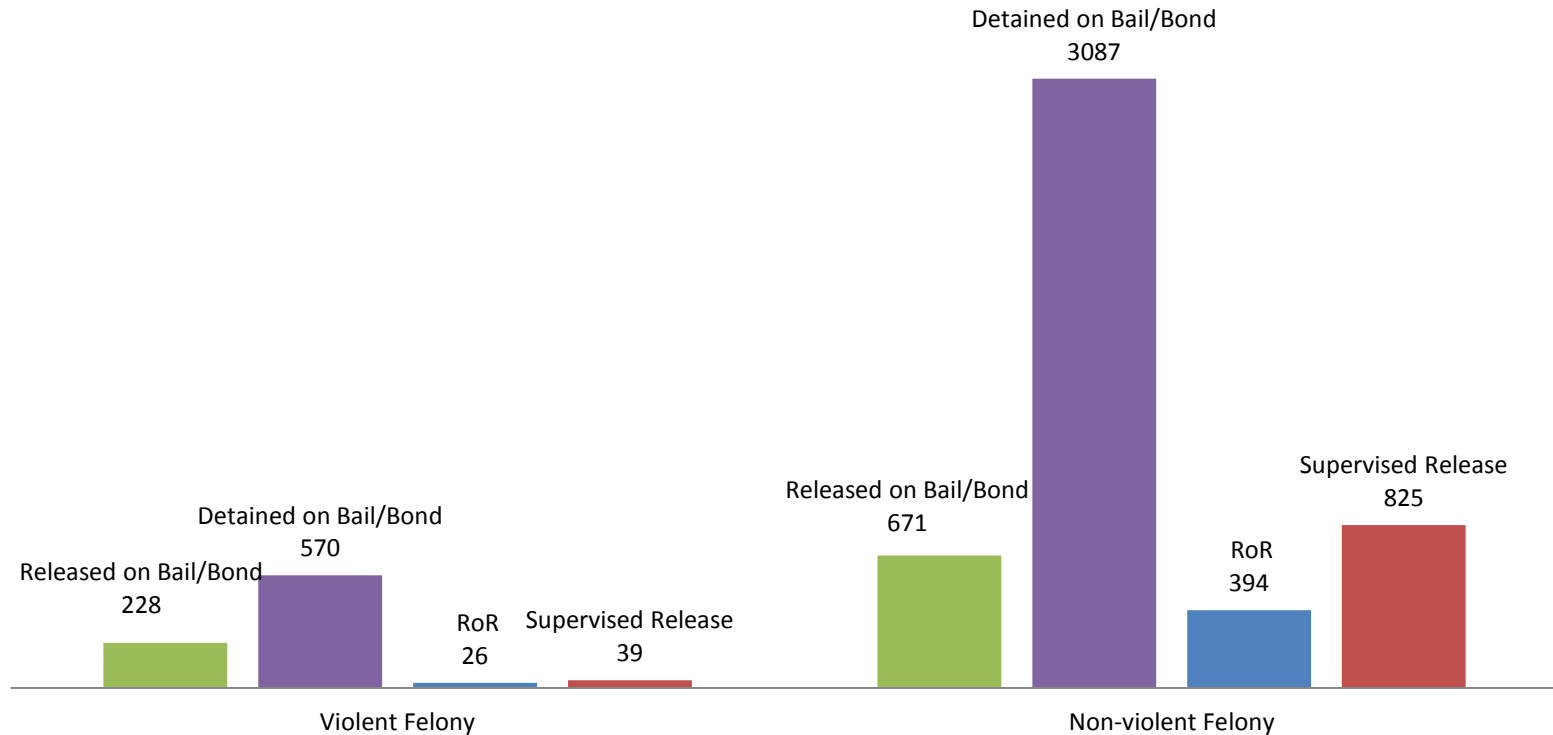
Superior Court Arraignment Outcomes by Charge



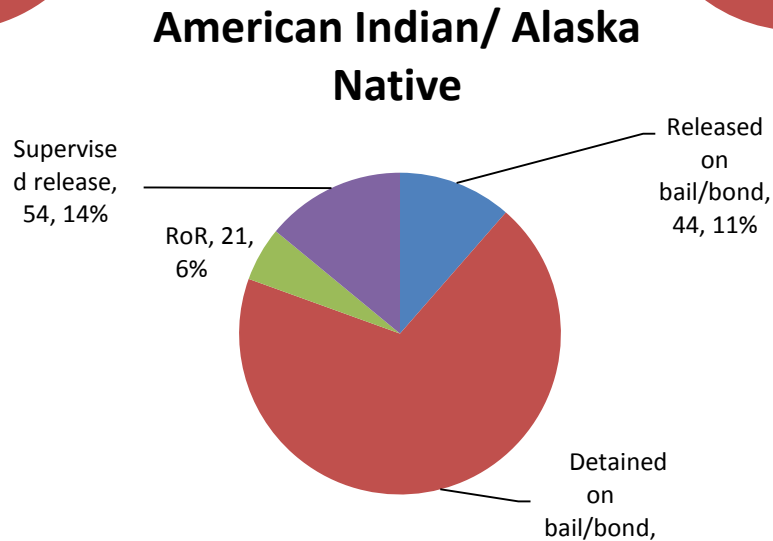
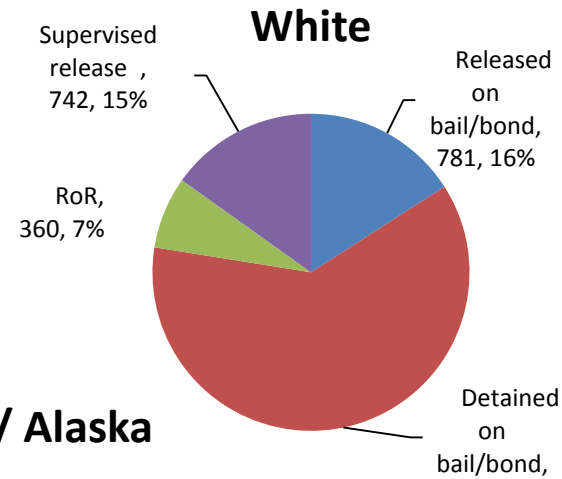
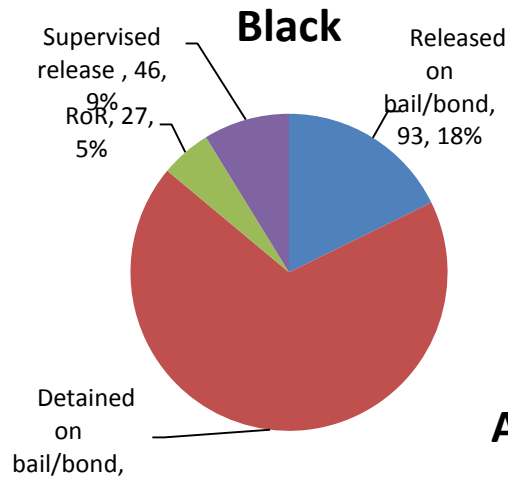
Arraignment Outcomes by Race

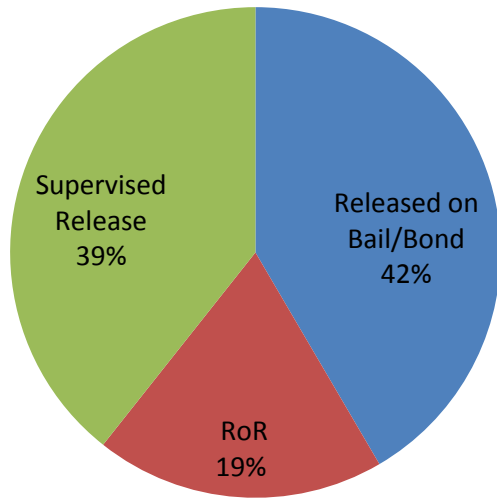

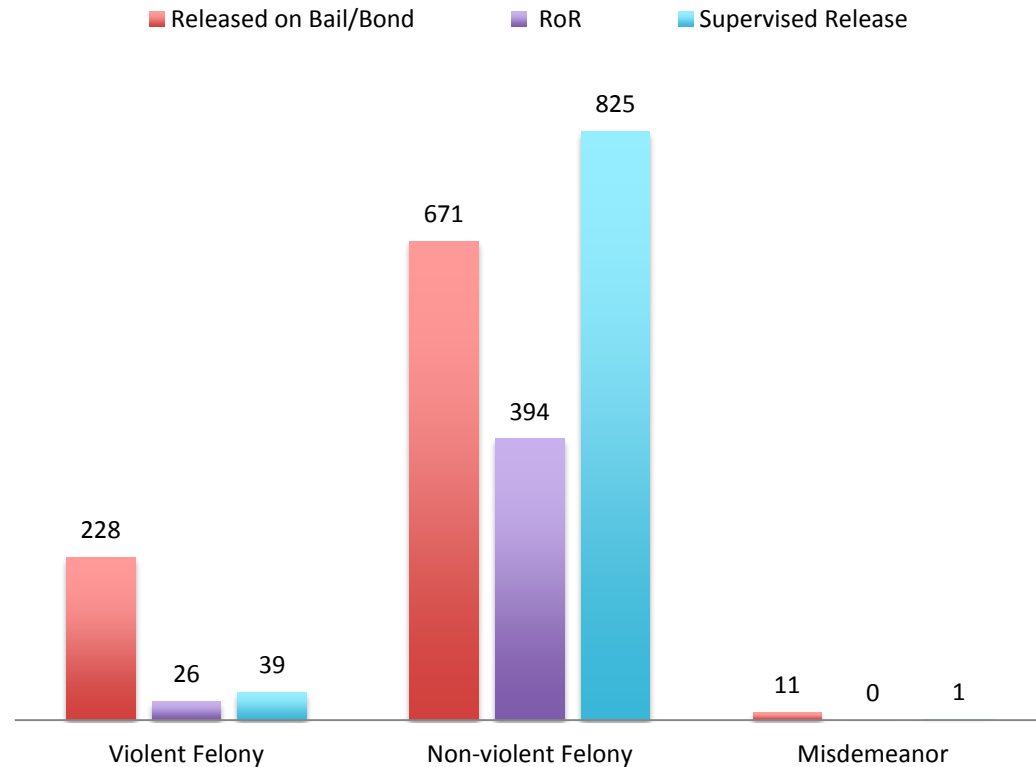

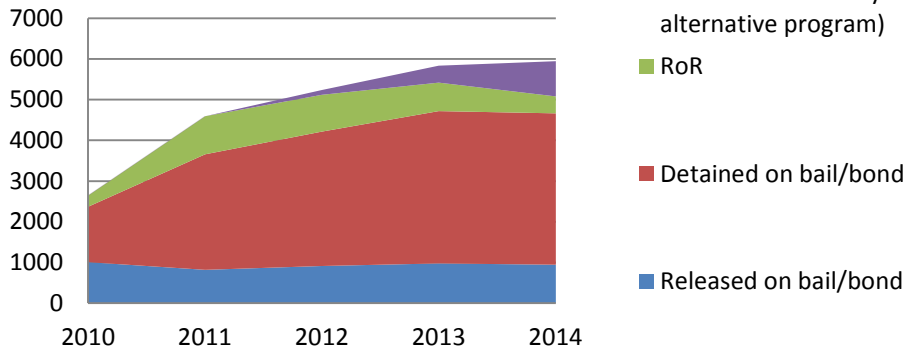


Pre-Trial Release for Continued Cases by Offense Type

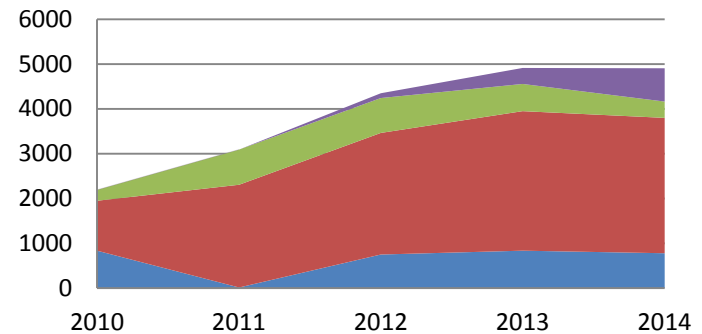

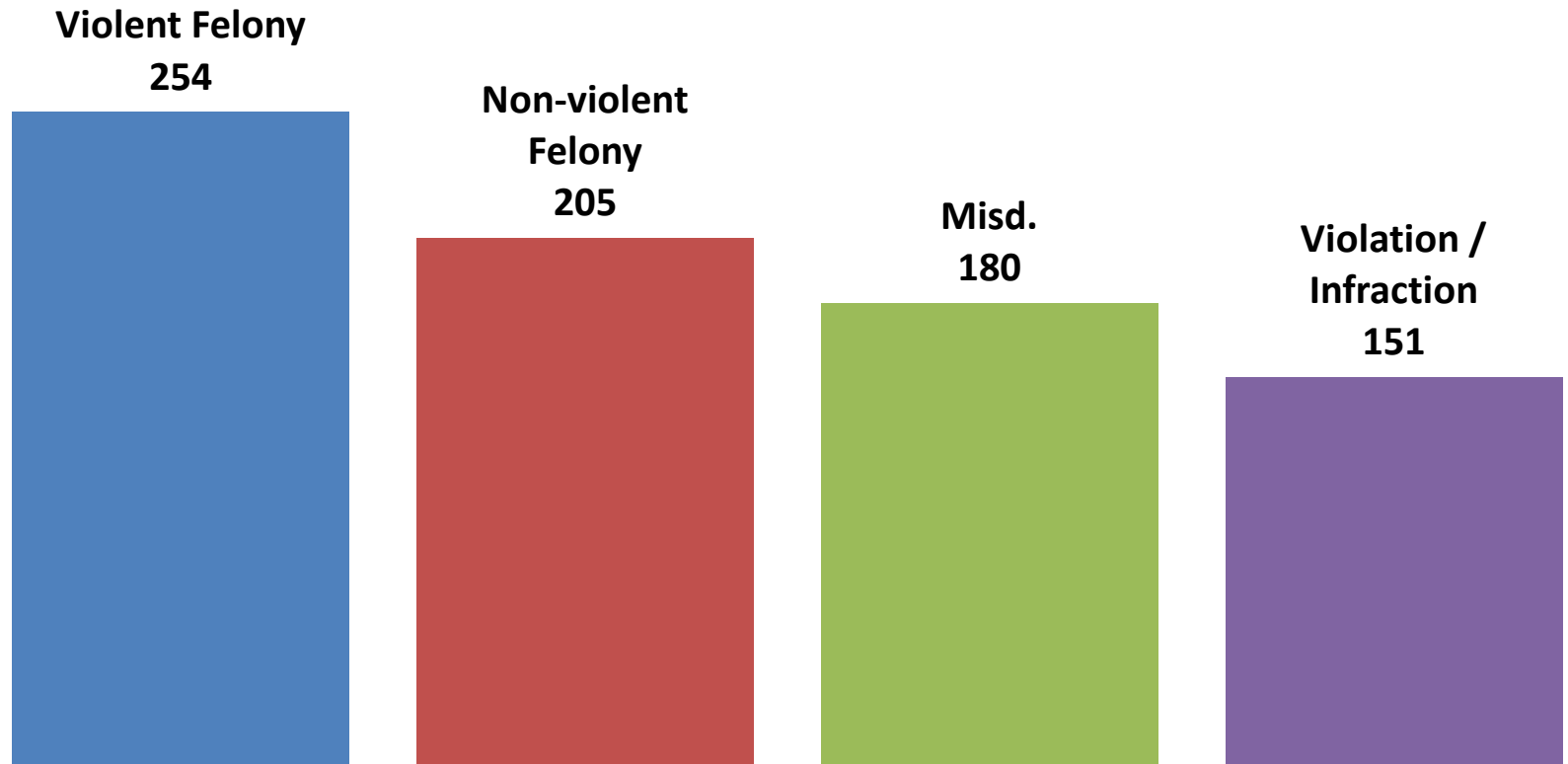
Municipal Court Release vs. Detainment by Race

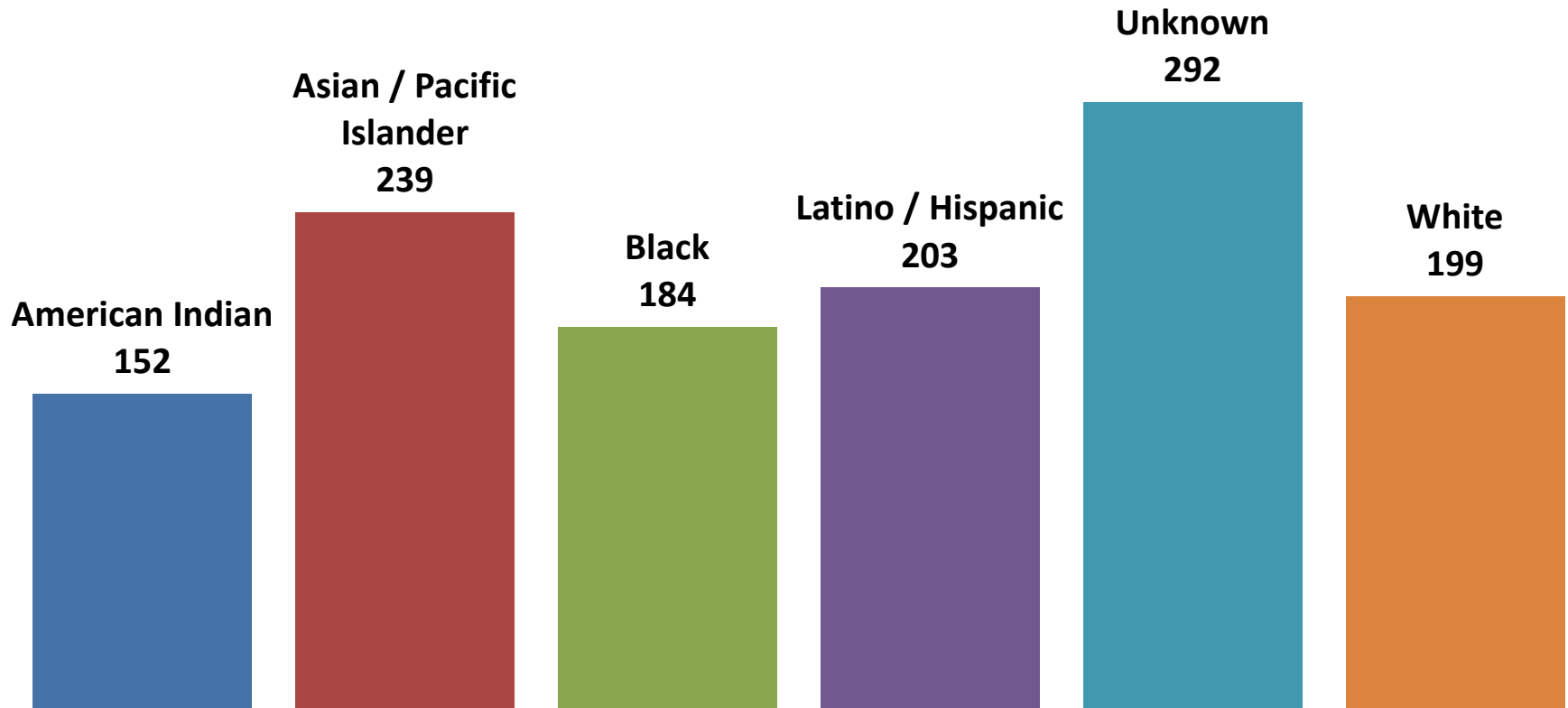
Average number of days between arraignment and disposition



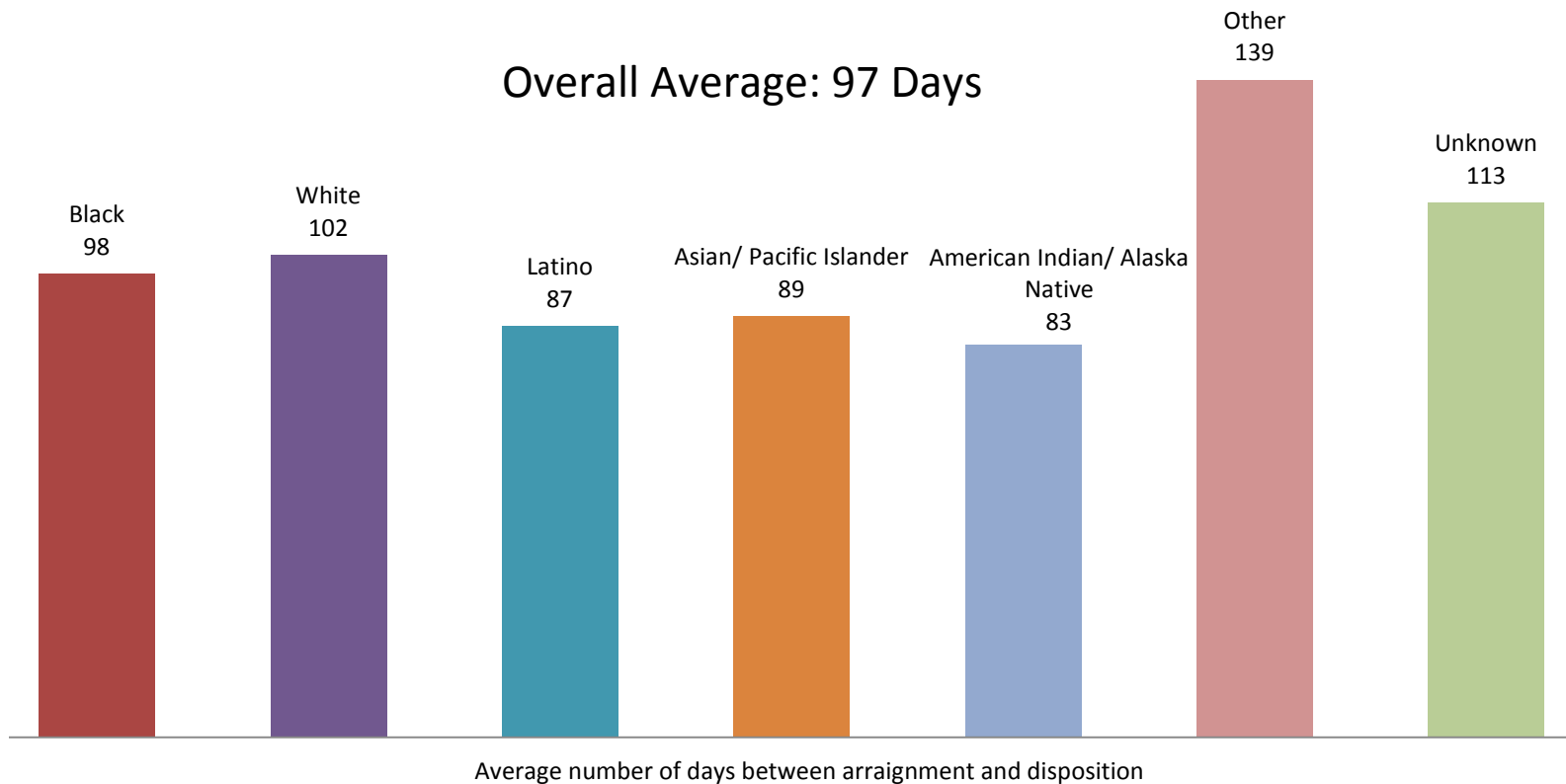

Average number of days between arraignment and disposition

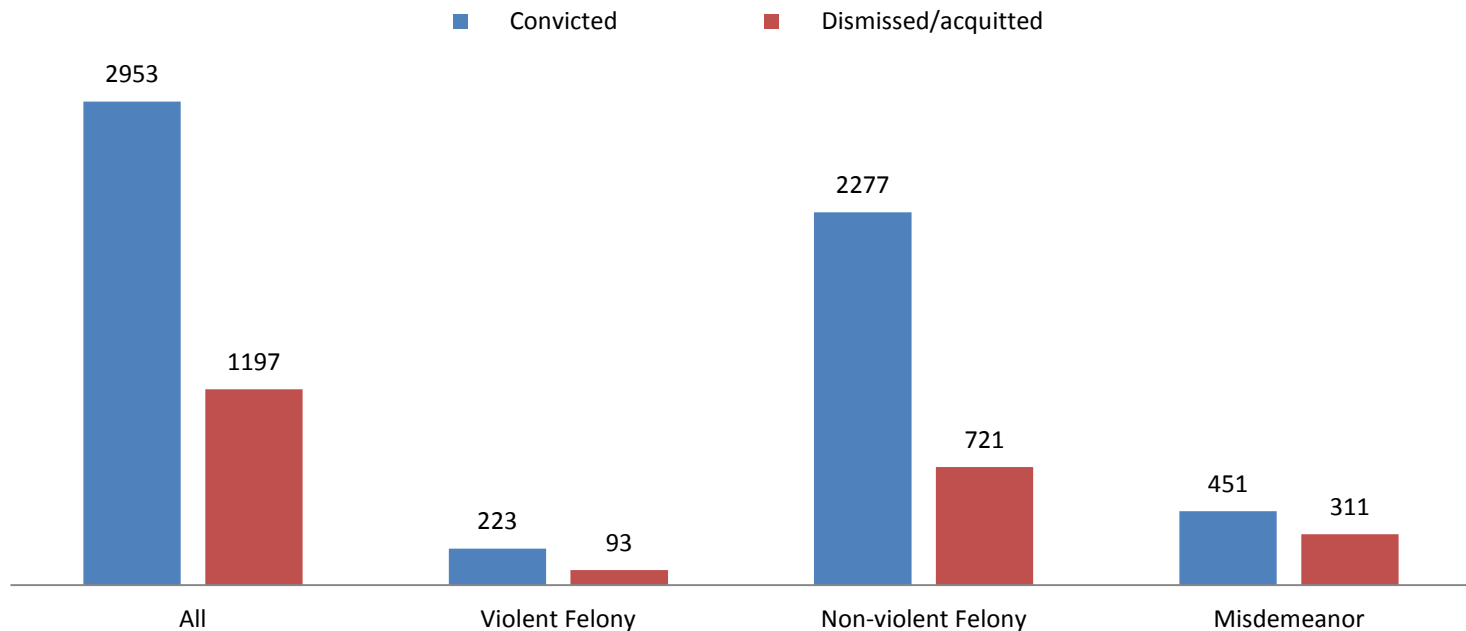


Municipal Court Average Number of Days between Arraignment and Disposition, by Race



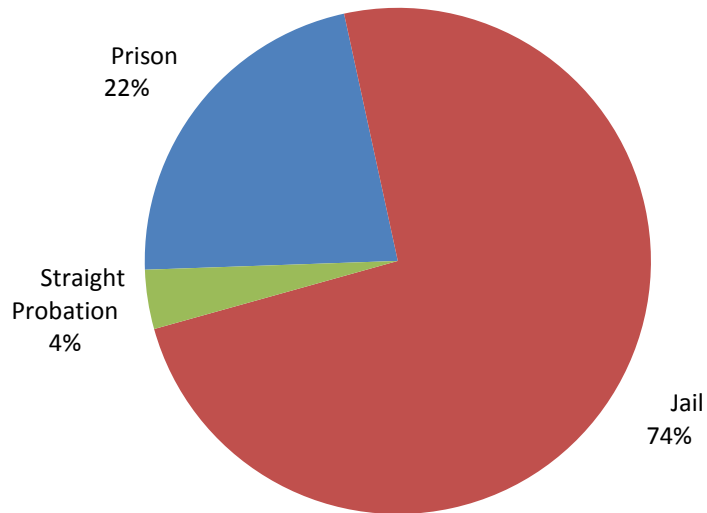
Dismissed vs. Convicted-Superior Court

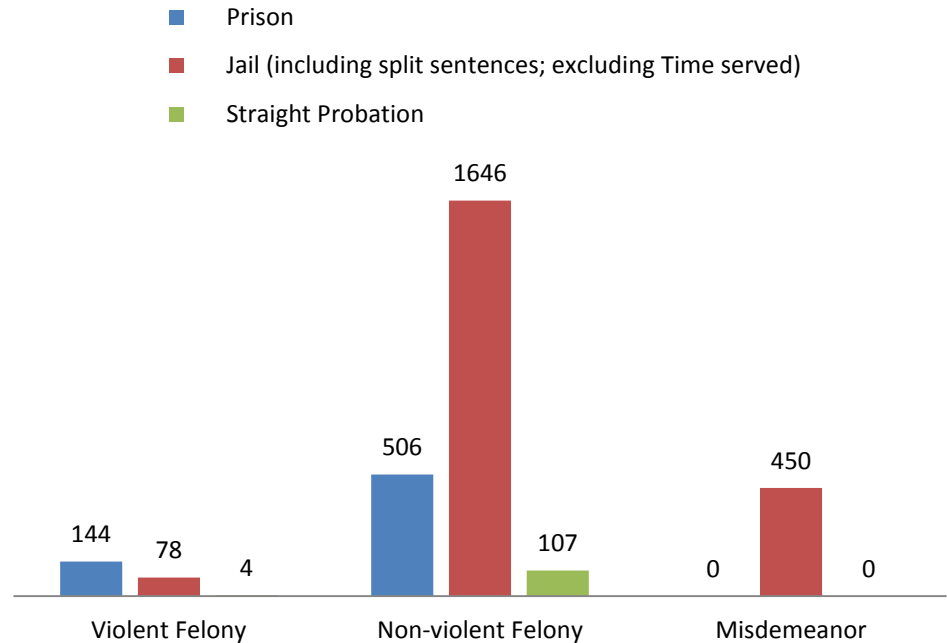


Convicted Cases by Sentencing

Sentence Breakdown of Superior Court Convicted Cases

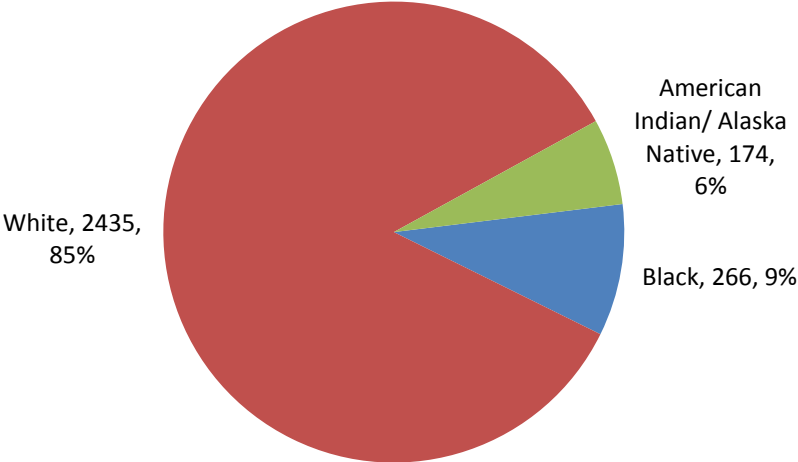


Sentence Breakdown by Offense Type

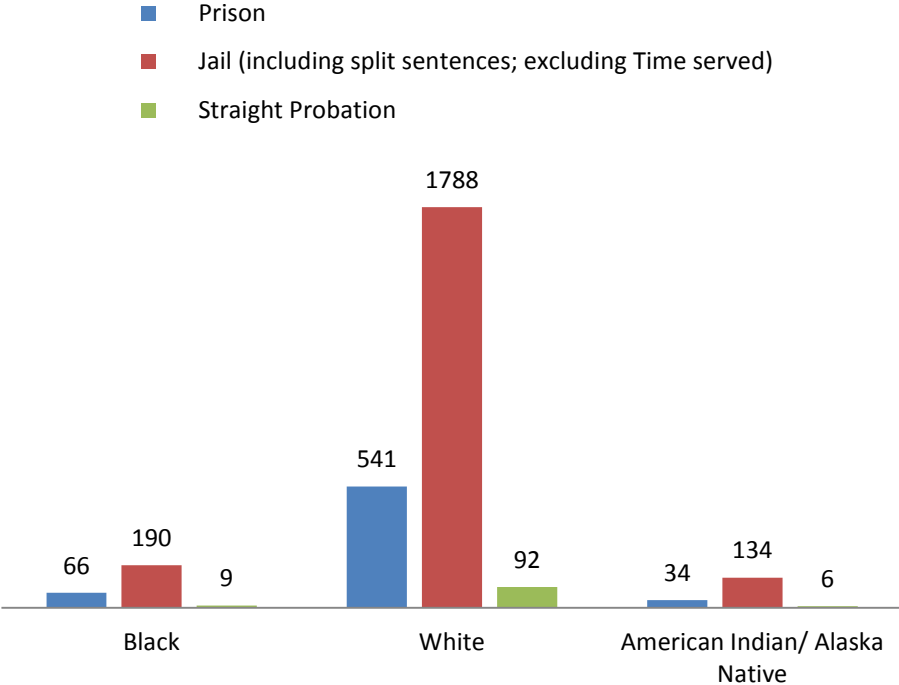


Sentencing by Race

Race of Convicted Individuals

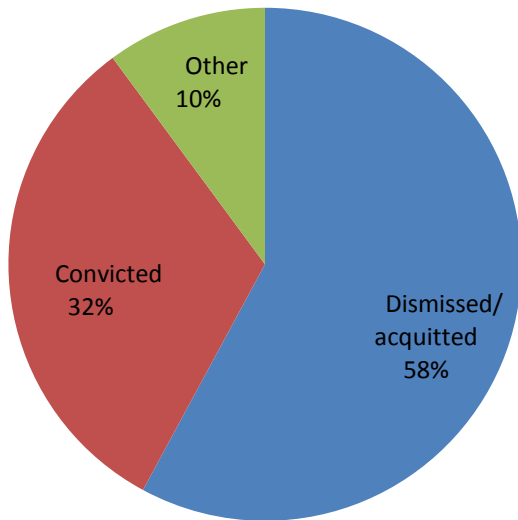
