

RESOLUTION NO. **15 - 0480**

BEFORE THE BOARD OF COUNTY COMMISSIONERS
OF SPOKANE COUNTY, WASHINGTON

IN THE MATTER OF AMENDING)
CHAPTER 6.06 OF THE SPOKANE) **RESOLUTION**
COUNTY CODE "NO SHOOTING AREA")

WHEREAS, the Washington State Constitution Article XI, Section 11, gives Spokane County the power to make and enforce within its limits all such police and sanitary and other regulations as are not in conflict with general laws; and

WHEREAS, the Board of County Commissioners of Spokane County, pursuant to the provisions of the Revised Code of Washington, Section 36.32.120(7) may make and enforce by appropriate resolution all such police regulations as are necessary; and

WHEREAS, a public hearing was held on May 18, 2015 at 4:00 p.m. to receive public testimony to include additional area within the Spokane County No Shooting Area referred to as the **"DNR/South Bank Rd Petition Area"** described as follows:

Generally described as property located in the South Bank Rd area south of the Spokane River in Nine Mile Falls, WA north of the Knight's lake area.

More particularly described as that portion of Section 6, Township 27 N, Range 41, E.W.M. - except the west half of the west half of said Section 6;

Together with the portion of Section 5, Township 27, Range 41, E.W.M., lying west of the Spokane River;

Together with that portion of Section 36, Township 28 N, Range 40, E.W.M., lying east of the Spokane River;

Together with that portion of Section 31, Township 28 N, Range 41, E.W.M., lying westerly, southerly and easterly of the Spokane River;

Together with that portion of Section 32, Township 28 N, Range 41, E.W.M., lying west of the Spokane River;

The areas bordered by said Spokane River shall extend north-east and west to the boundary of Spokane County.

WHEREAS, the Spokane County No Shooting Area Advisory Committee, pursuant to the provision of the Spokane County Code, Section 6.06.150, has submitted to the Board of County Commissioners a recommendation and map of the area; and

WHEREAS, the Board of County Commissioners met on June 16, 2015 at 2:00 p.m. in the Spokane County Public Works Building, Commissioners Assembly Room, located at 1026 W. Broadway Avenue, Spokane, Washington, as the time and place of public meeting to consider the recommendations of the Spokane County No Shooting Area Advisory Committee;

THEREFORE, BE IT HEREBY RESOLVED by the Board of County Commissioners of Spokane County, Washington, that based upon the recommendation of the Spokane County Shooting Area Advisory Committee and public testimony given at this public meeting, the area is recommended to be included in the Spokane County No Shooting Areas as a "No Shooting" area designation.

That portion of Section 6, Township 27 N, Range 41, E.W.M. - except the west half of the west half of said Section 6;

Together with the portion of Section 5, Township 27, Range 41, E.W.M., lying west of the Spokane River;

Together with that portion of Section 36, Township 28 N, Range 40, E.W.M., lying east of the Spokane River;

Together with that portion of Section 31, Township 28 N, Range 41, E.W.M., lying westerly, southerly and easterly of the Spokane River;

Together with that portion of Section 32, Township 28 N, Range 41, E.W.M., lying west of the Spokane River;

The areas bordered by said Spokane River shall extend north-east and west to the boundary of Spokane County.

The area described above and proposed as a "No Shooting Area" is hereby **APPROVED**.
