2. 100 percent of the green fees must be paid before the tournament starts with refunds given only if the course is closed by our staff.
3. The tournament will abide by all the rules of the golf course, including all liquor policies.
4. The Professional will make available a Starter, Score Sheets, Closest-to-the-Pin and Long-Drive markers. Callaway Scoring System is also available.
5. ALL SHOTGUN STARTS MUST USE GOLF CARTS and are required to have a minimum of 120 players at \$54 per person (Mon-Tue) or \$56.00 (Wed-Sun). **(Please Initial \_\_\_\_\_)**
6. Tournament Organizer will provide a complete list of pairings & starting times at least 1 hour prior to the start of the tournament.
7. **Due to Washington State Liquor and Cannabis Board laws, all beverages must be purchased through the golf course. We provide adequate refreshments at fair and reasonable prices. (Please Initial \_\_\_\_\_)**
8. Playing time for all tournaments will be 4-1/2 hours or less.
9. **MeadowWood Golf Course reserves the right to discontinue play due to violation of this contract at any time with no refunds. (Please Initial \_\_\_\_\_)**
