Sexually Violent Predator

- ▶ RCW 71.09.020.18

“Any person who has been convicted of or charged with a crime of sexual violence and who suffers from a mental abnormality or personality disorder which makes the person likely to engage in predatory acts of sexual violence if not confined in a secure facility.”



Less Restrictive Alternative

RCW 71.09

DOC Policy 380.370

Conditional Release to LRA

- ▶ RCW 71.09.096.1

“If the court or jury determines that conditional release to a less restrictive alternative is in the best interest of the person and includes conditions that would adequately protect the community, and the court determines that the minimum conditions set forth in RCW [71.09.092](#) and in this section are met, the court shall enter judgment and direct a conditional release.”

CCU CCO Responsibility Cont.

- ▶ Partnership with Law Enforcement
- ▶ Deposition and Trial
- ▶ SCC Senior Clinical Team Meetings
- ▶ Court Notification
- ▶ GPS Monitoring
- ▶ Resident Itineraries
- ▶ Resident Proposals/unique proposals
- ▶ Emergency medical routes
- ▶ Schooling and Employment survey

Unique Conditions

- ▶ GPS
- ▶ Trip Plans
- ▶ Contact restrictions
- ▶ Site restrictions
- ▶ Logging
- ▶ Point to point calls
- ▶ Contact requirements
- ▶ Media restrictions
- ▶ Route restriction
- ▶ Proposal process
- ▶ Behavioral expectations
- ▶ Treatment compliance
- ▶ Anytime searches
- ▶ Court authority over residence

Investigations

- ▶ DOC receives an order to investigate by the court
 - Proposed residence is surveyed to ensure that it meets court requirements
 - ▶ CCO will:
 - Review SCC and DOC records
 - View location
 - Conduct interviews
 - Recommend conditions
- **DOC DOES NOT RECOMMEND IF HOUSING IS APPROPRAITE**
