

Spokane County Interstate Fair CAMPING APPLICATION

- ✓ There are limited camping spaces available and therefore campers must be Fair exhibitors or employees to use designated RV / Camping sites. Only recreational type vehicles and tents are allowed in the camping area.
- ✓ The space assigned to you will accommodate your trailer with towing unit, RV, OR camper plus one car.
- ✓ Space sizes (width and length) are extremely important to guarantee that we have a space big enough to accommodate you. Please be sure to list the width based upon a fully extended size (sliders extended). Length is "tip to tail" of your sleeping unit. In most cases, the towing unit will need to be unhooked. Awnings cannot be extended.
- ✓ Camping will NOT be permitted inside Blue Gate 2.
- ✓ Exhibitors are asked to leave their pets at home. If pets must accompany an exhibitor, they must remain in the camping area, must be on a secure leash if tied outside, and the exhibitor must pick up after them.
- ✓ Those camping at the Fair and Expo Center are encouraged to bring a 100' extension cord with them.
- ✓ Sites may not be occupied prior to 8:00 a.m. on Thursday, September 6, 2018.
- ✓ Only persons having exhibits in the Fair between Sept. 7 and Sept. 12 can use sites during that period.
- ✓ Persons not exhibiting in the Fair during the second half of the Fair shall remove their RVs or tents prior to Noon on Wednesday, September 13. Spaces for second half exhibitors will be available by 2:00 p.m.
- ✓ Upon arrival at the Fair, please check in at the Livestock (Red) Gate and you will be directed to your camping space.
- ✓ Camping permits must be displayed on your camping vehicle (in a window near the living unit's door is preferred).
- ✓ Camping fee of \$22.00 per night must accompany permit and must be received by the Fair between July 1 and August 7. Sites will be assigned based upon the date the payment is received. Sites in the campground will be assigned first to those staying all ten days of the Fair.
- ✓ Tent Camping will be assessed at \$8.00 per night per tent.
- ✓ Owners of campers/RVs/trailers visiting the Spokane County Fair & Expo Center campsites will hold Spokane County harmless for any damage sustained to their trailer/camper/RV while being parked. Spokane County is also not responsible for any stolen items from the campsite.
