This is the third of four public hearings the committee will host throughout the process to draw five new county commissioner districts for Spokane County. The committee published a [draft redistricting plan](#) on Aug. 24 and wishes to receive formal public comment from people and organizations across Spokane County.

The committee expects to work toward a final plan in October and will hold one additional public hearing on Oct. 7 before considering a final plan for approval. **Public comment on the draft plan and any revised plans will be accepted through Oct. 12.** The final redistricting plan must be submitted to the Spokane County Auditor's Office by Oct. 23, 2021.
