<sup>1</sup> A record on "Hold" refers to individuals who face a detainer order or other circumstances that prevents an immediate release on bail. A "Pre Trial – No Hold" refers to individuals with pending charges who do not have a detainer order and could be immediately released on bond. A "Pre Trial – Hold" refers to individuals with pending charges and have a detainer order and would be held in custody even if bail was posted. A "Hold" refers to individuals who are in jail only for a detainer order and do not face any additional pending charges.

<sup>2</sup> Currently available data do not disaggregate misdemeanors by County, City and Valley charges. Because the County is billed for all felony charges, this combined category is attributed to Spokane County (as a Billing Agency).
