

ORDINANCE NO. 451

AN ORDINANCE OF THE TOWN OF SPANGLE, WASHINGTON, PROVIDING FOR THE SUBMISSION TO THE VOTERS OF THE TOWN OF SPANGLE AT A GENERAL ELECTION TO BE HELD THEREIN ON NOVEMBER 8th, 2022, OF A PROPOSITION AS TO WHETHER A SPECIAL EXCESS LEVY ON REAL PROPERTY SHALL BE AUTHORIZED TO PROVIDE \$17,000.00 IN 2023 FOR POLICE PROTECTION SERVICES TO THE TOWN VIA A POLICE PROTECTION SERVICES CONTRACT WITH SPOKANE COUNTY SHERIFF'S OFFICE.

WHEREAS, the General Fund of the Town of Spangle is inadequate to pay the cost of a Police Services Contract with Spokane County Sheriff's Office for the year 2023;

WHEREAS, no other funds, grants, or loans are available to defray the cost of a Police Protection Services Contract with Spokane County Sheriff's Office for the year 2023;

WHEREAS, to adequately protect the Town of Spangle, its citizens and provide adequate Police Protection Services and the funds for such police protection services must come from a source other than the General Fund of the Town of Spangle; and,

WHEREAS IT IS NECESSARY AND DESIRABLE TO RAISE THE NEEDED FUNDS BY AN EXCESS LEVY IF APPROVED BY THE VOTERS OF THE Town of Spangle at the election to be held on November 8th, 2022 and if passed, levied in 2022, for collection in 2023

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF SPANGLE AS FOLLOWING

Section I

That the following proposition be placed on the ballot of the General Election to be held in the Town of Spangle on November 8th, 2022, to wit:

PROPOSITION NO. 2

TOWN OF SPANGLE

POLICE PROTECTION SERVICE EXCESS LEVY

The Spangle Town Council enacted Ordinance NO. 451 concerning a proposition to finance the 2023 Police Protection Services. This proposition would authorize the Town to levy an excess property tax in 2023 on all taxable property with the Town of Spangle in an approximate rate of \$1.19 per \$1,000 of assessed value to raise \$17,000.00 to be used to provide adequate police protection services in 2023. 
County Elections

The Town Clerk is authorized and directed to present a certified copy of this Ordinance to the Spokane County Auditor no later than August 2nd, 2022, 91 days before the November 8th, 2022 General Election; to submit the ballot proposition set forth above to the qualified electors of the Town of Spangle at the election; and, to take all

actions and do all things necessary to cause the ballot proposition described above to be submitted properly to the qualified electors of the Town of Spangle at the November 8th, 2022 General Election.

THE DEADLINE for submission of ballot propositions to the Spokane County Auditor requires this Ordinance to be enacted and submitted no later than August 2nd, 2022 This Ordinance shall be effective immediately upon passage.
