SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

The CPP was first adopted in the early 1990s but have not been substantially updated since that time. On May 18, 2022 the subcommittee of the SCEO requested the PTAC review and provide recommended updates to the CPP in preparation for the mandated periodic update scheduled for June 30, 2026. Since that directive, the SCEO Planning Technical Advisory Committee conducted several working meetings to prepare the preproposed revisions to the Spokane County CPPs. The SCEO held a workshop on August 17th 2022 as well as September 21st, 2022 to discuss the proposed changes. A public hearing before the SCEO is anticipated to be held on October 19th 2022, for their recommendation to the board of county commissioners.

The proposed amendments are being prepared in anticipation of the required 2026 Comprehensive Plan Update.

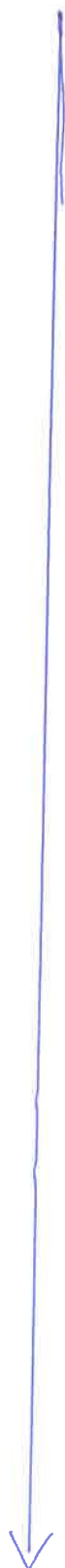

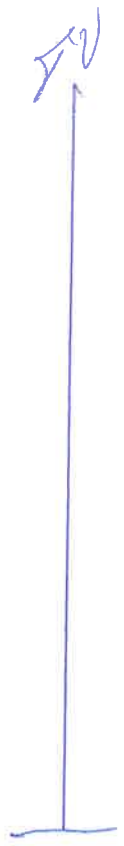
