- Reconstructed the positions of Bodman's Vehicle, Mazda, and Holyk
- Reiterated Holyk was down ~.03 second by the time deputy Bodman arrived in the crosswalk.
- With 20+ years accident reconstruction experience Origin Engineering concluded that the officer was trained well and steered away from Holyk.
- Confirmed Deputy Bodman's vehicle did not make contact with Holyk or his bicycle.

Medical Examiner again declined to come to this meeting to meet with the CAB based on Holyk's death classified as an accident, not a homicide.
